SUMMARY: (U) NUMEROUS UFO SIGHTINGS HAVE BEEN MADE IN BELGIUM SINCE NOV 89. THE CREDIBILITY OF SOME INDIVIDUALS MAKING THE REPORTS IS GOOD. SOME SIGHTINGS HAVE BEEN EXPLAINED BY NATURAL/MANMADE PHENOMENA, SOME HAVE NOT. INVESTIGATION BY THE BAF CONTINUES.

TEXT: 1. (U) NUMEROUS AND VARIOUS ACCOUNTS OF UFO SIGHTINGS HAVE SURFACED IN BELGIUM OVER THE PAST FEW MONTHS. THE CREDIBILITY OF THE OBSERVERS OF THE ALLEGED EVENTS VARIES FROM THOSE WHO ARE UNSOPHISTICATED TO THOSE WHO ARE THE WELL EDUCATED AND PROMINENTLY PLACED.

2. (U) SOURCE A CITES MR LEON BRENIQ, A 43 YEAR OLD PROFESSOR AT THE FREE UNIVERSIY OF BRUSSELS (PROMINENT) IN THE FIELD OF STATISTICS AND PHYSICS. HE CLAIMS TO HAVE TAKEN PICTURES OF THE PHENOMENA WHICH ARE STILL BEING DEVELOPED BUT WILL BE PUBLISHED BY THE BELGIAN SOCIETY FOR THE STUDY OF SPACE PHENOMENA IF THEY ARE OF GOOD QUALITY.

3. (U) MR BRENIQ WAS DRIVING ON THE ARDENNES AUTOROUTE IN THE BEAUFAYS REGION EAST OF LIEGE, SUNDAY, 18 MARCH 1990 AT 2030 HOURS WHEN HE OBSERVED AN AIRBORNE OBJECT APPROACHING IN HIS DIRECTION FROM THE NORTH. IT WAS IN THE FORM OF A TRIANGLE ABOUT THE SIZE OF A PING-PONG-BALL AND HAD A YELLOW LIGHT SURROUNDING IT WITH A REDDISH CENTER VARYING IN INTENSITY. ALTITUDE APPEARED TO BE 500 - 1000 METERS, MOVING AT A SLOW SPEED WITH NO SOUND. IT DID NOT MOVE OR BEHAVE LIKE AN AIRCRAFT.

4. (U) MR BRENIQ CONTACTED A FRIEND VERY NEAR THE AREA WHO CAME OUT AND TOOK PICTURES OF IT WITH A ZOOM LENS AND 400 ASA FILM. BOTH INSISTED THE OBJECT COULD NOT BE AN AIRCRAFT OR HOLOGRAMME PROJECTION AS THE SKY WAS CLOUDLESS.

5. (U) THE SOURCE B ARTICLE WHICH DISCUSSES A BELGIAN TELEVISION INTERVIEW WITH COL WIL ((DEBROUWER)), CHIEF OF



OPERATIONS FOR THE BAF, MOST LIKELY WAS THE RESULT OF A FOLLOW-ON ACTION TAKEN BY MR BRENIQ WHEN HE CONTACTED LTGEN ((TERRASSON)), COMMANDER, BELGIAN TACTICAL (OPERATIONAL) COMMAND. GEN TERRASSON CATEGORICALLY ELIMINATED ANY POSSIBLE BAF AIRCRAFT OR ENGINE TEST INVOLVEMENT WHICH COL DEBROUWER CONFIRMED DURING THE 25

6. (U) DEBROUVER NOTED THE LARGE NUMBER OF REPORTED SIGHTINGS, PARTICULARLY IN NOV 89 IN THE LIEGE AREA AND THAT THE BAF AND MOD ARE TAKING THE ISSUE SERIOUSLY. BAF EXPERTS HAVE NOT BEEN ABLE TO EXPLAIN THE PHENOMENA EITHER.

7. (U) DESBROUWER SPECIFICALLY ADDRESSED THE POSSIBILITY OF THE OBJECTS BEING USAF B-2 OR F-117 STEALTH AIRCRAFT WHICH WOULD NOT APPEAR ON BELGIAN RADAR, BUT MIGHT BE SIGHTED VISUALLY IF THEY WERE OPERATING AT LOW ALTITUDE IN THE ARDENNES AREA. HE MADE IT QUITE CLEAR THAT NO USAF OVERFLIGHT REQUESTS HAD EVER BEEN RECEIVED FOR THIS TYPE MISSION AND THAT THE ALLEGED OBSERVATIONS DID NOT CORRESPOND IN ANY WAY TO THE OBSERVABLE CHARACTERISTICS OF EITHER U.S. AIRCRAFT.

8. (U) MR BRENIQ HAS SINCE ASSURED THE COMMUNITY THAT HE IS PERSONALLY ORGANIZING A NEW UFO OBSERVATION CAMPAIGN AND SPECIFICALLY REQUESTS THE HELP OF THE BELGIAN MOD.

9. [REDACTED] RELATED A SIMILAR UFO SIGHTING WHICH APPARENTLY HAPPENED TO A BELGIAN AIR FORCE OFFICER IN THE SAME AREA NEAR LIEGE DURING NOVEMBER 89. THE OFFICER AND HIS WIFE WERE ALLEGEDLY BLINDED BY A HUGE BRIGHT FLYING OBJECT AS THEY WERE DRIVING ON THE AUTOROUTE. THEY STOPPED THEIR CAR, BUT WERE SO FRIGHTENED THEY ABANDONED THE VEHICLE AND RAN INTO THE WOODS. THEY COULD NOT PROVIDE A DETAILED DESCRIPTION BUT WHATEVER IT WAS DEFINITELY APPEARED REAL TO THEM. [REDACTED] UNDERLINED THEIR CREDIBILITY AS SOLID.

COMMENTS: 1. [REDACTED] COMMENT. HE COULD PROVIDE VERY LITTLE CONCRETE INFORMATION EXCEPT TO VERIFY THE LARGE VOLUME OF SIGHTINGS AND THE SIMILARITY OF SOME DURING NOV 89.

2. [REDACTED] THE BAF HAS RULED SOME SIGHTINGS WERE CAUSED BY INVERSION LAYERS, LAZER BEAMS AND OTHER FORMS OF HIGH INTENSITY LIGHTING HITTING CLOUDS. BUT A REMARKABLE NUMBER OCCURRED ON CLEAR NIGHTS WITH NO OTHER EXPLAINABLE ACTIVITY NEARBY.

3. [REDACTED] THE BAF IS CONCERNED TO A POINT ABOUT THE UFO ISSUE AND IS TAKING ACTION TO INVESTIGATE INFORMATION THEY HAVE. [REDACTED] DOES ADMIT, HOWEVER, THAT HE IS NOT OPTIMISTIC ABOUT RESOLVING THE PROBLEM.

4. [REDACTED] FIELD COMMENT. THE USAF DID CONFIRM TO THE BAF AND BELGIAN MOD THAT NO USAF STEALTH AIRCRAFT WERE OPERATING IN THE ARDENNES AREA DURING THE PERIODS IN [REDACTED]

 Force) #1642, were formed. At 2340hrs., 15 Nov 77, the following information was learned: Upon arrival (2132hrs) at Site #L-9, LSAT, JENKINS & RAEKE, dismounted the SAT vehicle and RAEKE proceeded to the source of the light to investigate. At this time RAEKE observed a bright light shining vertically upwards from the rear of the fence line of L-9. (There is a small hill approximately 50 yards behind L-9) JENKINS stayed with the SAT vehicle and RAEKE proceeded to the source of the light to investigate. As RAEKE approached the crest of the hill, he observed an individual dressed in a green metallic uniform and wearing a helmet with visor. RAEKE immediately challenged the individual, however; the individual refused to stop and kept walking towards the rear fence line of L-9. RAEKE aimed his M-16 rifle at the intruder and ordered him to stop. The intruder turned towards RAEKE and aimed a object at RAEKE which emitted a bright flash of intense light. The flash of light struck RAEKE'S M-16 rifle, discharging the weapon and causing second and third degree burns to RAEKE'S hands. RAEKE immediately took cover and concealment and radioed the situation to JENKINS, who in turn radioed a 10-13 distress to Lima Control. JENKINS responded to RAEKE'S position and carried RAEKE back to the SAT vehicle. JENKINS then returned to the rear fence line to stand guard. JENKINS observed two intruders dressed in the same uniforms, walk through the rear fence line of L-9. JENKINS challenged the two individuals but they refused to stop. JENKINS aimed and fired two rounds from his M-16 rifle. One bullet struck one intruder in the back and one bullet struck one intruder in the helmet. Both intruders fell to the ground, however, approximately 15 seconds later both returned to an upright position and fired several flashes of light at JENKINS. JENKINS took cover and the light missed JENKINS. The two intruders returned to the east side of the hill and disappeared. JENKINS followed the two and observed them go inside a saucer shaped object approximately 20' in diameter and 20' thick. The object emitted a glowing greenish light. Once the intruders were inside, the object climbed vertically upwards and disappeared over the Eastern horizon. EAF #1 arrived at the site at 2230hrs., and set up a security perimeter. Site Survey Teams arrived at the site (0120hrs.) and took radiation readings, which measured from 1.7 to 2.9 roentgens. (Missile Maintenance examined the missile and warhead and found the normal components missing from the warhead.) COL. SPRAKER, Wing Cdr., arrived at the site

Evacuated the site at 0120hrs. All personnel, except all non-essential personnel, were evacuated out of the area. All evidence found at the scene and the follow-up report will be classified by order of COL. Spraker.
 ADDITIONAL INFORMATION: RAEKE was treated at the Base Hospital by MOD (Capt) Sanders for second and third degree radiation burns to each hand. RAEKE was Air-Lifted to an unspecified location. RAEKE'S M-16 rifle could not be located at the site.

Dear Ambassador Griffith:

I wanted to convey to you my views on our extra-terrestrial visitors popularly referred to as "UFO's", and suggest what might be done to properly deal with them.

I believe that these extra-terrestrial vehicles and their crews are visiting this planet from other planets, which obviously are a little more technically advanced than we are here on earth. I feel that we need to have a top level, coordinated program to scientifically collect and analyze data from all over the earth concerning any type of encounter, and to determine how best to interface with these visitors in a friendly fashion. We may first have to show them that we have learned to resolve our problems by peaceful means, rather than warfare, before we are accepted as fully qualified universal team members. This acceptance would have tremendous possibilities of advancing our world in all areas. Certainly then it would seem that the UN has a vested interest in handling this subject properly and expeditiously.

I should point out that I am not an experienced UFO professional researcher. I have not yet had the privilege of flying a UFO, nor of meeting the crew of one. I do feel that I am somewhat qualified to discuss them since I have been into the fringes of the vast areas in which they travel. Also, I did have occasion in 1951 to have two days of observation of many flights of them, of different sizes, flying in fighter formation, generally from east to west over Europe. They were at a higher altitude than we could reach with our jet fighters of that time.

I would also like to point out that most astronauts are very reluctant to even discuss UFO's due to the great numbers of people who have indiscriminately sold fake stories and forged documents abusing their names and reputations without hesitation. Those few astronauts who have continued to have a participation in the UFO field have had to do so very cautiously. There are several of us who do believe in UFO's and who have had occasion to see a UFO on the ground, or from an airplane. There was only one occasion from space which may have been a UFO.

If the UN agrees to pursue this project, and to lend their credibility to it, perhaps many more well qualified people will agree to step forth and provide help and information.

I am looking forward to seeing you soon.

Here is what I remember of that evening.



§ 1211.100 Scope.

This part establishes:

(a) NASA policy, responsibility and authority to guard the Earth against any harmful contamination or adverse changes in its environment resulting from personnel, spacecraft and other property returning to the Earth after landing on or coming within the atmospheric envelope of a celestial body; and

(b) Security requirements, restrictions and safeguards that are necessary in the interest of the national security.

§ 1211.101 Applicability.

The provisions of this part apply to all NASA manned and unmanned space missions which land on or come within the atmospheric envelope of a celestial body and return to the Earth.

§ 1211.102 Definitions.

(a) "NASA" and the "Administrator" mean, respectively the National Aeronautics and Space Administration and the Administrator of the National Aeronautics and Space Administration or his authorized representative (see § 1204.509 of this chapter).

(b) "Extraterrestrially exposed" means the state or condition of any person, property, animal or other form of life or matter whatever, who or which has:

(1) Touched directly or come within the atmospheric envelope of any other celestial body; or

(2) Touched directly or been in close proximity to (or been exposed indirectly to) any person, property, animal or other form of life or matter who or which has been extraterrestrially exposed by virtue of paragraph (b)(1) of this section.

For example, if person or thing "A" touches the surface of the Moon, and on "A's" return to the Earth, "B" touches "A" and, subsequently, "C" touches "B," all of these—"A" through "C" inclusive—would be extraterrestrially exposed ("A" and "B" directly; "C" indirectly).

(c) "Quarantine" means the detention, examination and decontamination of any person, property, animal or other form of life or matter whatever that is extraterrestrially exposed, and includes the apprehension or seizure of such person, property, animal or other form of life or matter whatever.

(d) "Quarantine period" means a period of consecutive calendar days as may be established in accordance with § 1211.104(a).

(e) "United States" means the 50 States, the District of Columbia, the Commonwealth of Puerto Rico, the Virgin Islands, Guam, American Samoa and any other territory or possession of the United States, and in a territorial sense all places and waters subject to the jurisdiction of the United States.

§ 1211.103 Authority.

(a) Sections 203 and 304 of the National Aeronautics and Space Act of 1958, as amended (42 U.S.C. 2473, 2455 and 2456).

(b) 18 U.S.C. 799.

(c) Article IX, Outer Space Treaty, TIAS 6347 (18 UST 2416).

(d) NASA Management Instructions 1052.90 and 8020.13.

§ 1211.104 Policy.

(a) *Administrative actions.* The Administrator or his designee as authorized by § 1204.509 of this chapter shall in his discretion:

(1) Determine the beginning and duration of a quarantine period with respect to any space mission; the quarantine period as it applies to various life forms will be announced.

National Aeronautics and Space Admin.**§ 1211.104**

(2) Designate in writing quarantine officers to exercise quarantine authority.

(3) Determine that a particular person, property, animal, or other form of life or matter whatever is extraterrestrially exposed and quarantine such person, property, animal, or other form of life or matter whatever. The quarantine may be based only on a determination, with or without the benefit of a hearing, that there is probable cause to believe that such person, property, animal or other form of life or matter whatever is extraterrestrially exposed.

(4) Determine within the United States or within vessels or vehicles of the United States the place, boundaries, and rules of operation of necessary quarantine stations.

(5) Provide for guard services by contract or otherwise, as may be necessary, to maintain security and inviolability of quarantine stations and quarantined persons, property, animals, or other form of life or matter whatever.

(6) Provide for the subsistence, health, and welfare of persons quarantined under the provisions of this part.

(7) Hold such hearings at such times, in such manner and for such purposes as may be desirable or necessary under this part, including hearings for the purpose of creating a record for use in making any determination under this part or for the purpose of reviewing any such determination.

(8) Cooperate with the Department of Health, Education, and Welfare and the Department of Agriculture in accordance with the provisions of § 1211.105.

(9) Take such other actions as may be prudent or necessary and which are consistent with this part.

(b) *Quarantine.* (1) During any period of announced quarantine, the property within the posted perimeter of the Lunar Receiving Laboratory at the Manned Spacecraft Center, Houston, Tex., is designated as the NASA Lunar Receiving Laboratory Quarantine Station.

(2) Other quarantine stations may be established if determined necessary as provided in paragraph (a)(4) of this section.

(3) During any period of announced quarantine, no person shall enter or depart from the limits of any quarantine station without permission of the cognizant NASA quarantine officer. During such period, the posted perimeter of a quarantine station shall be secured by armed guard.

(4) Any person who enters the limits of any quarantine station during the quarantine period shall be deemed to have consented to the quarantine of his person if it is determined that he is or has become extraterrestrially exposed.

(5) At the earliest practicable time, each person who is quarantined by NASA shall be given a reasonable opportunity to communicate by telephone with legal counsel or other persons of his choice.

§ 1211.105 Relationship with Departments of Health, Education, and Welfare and Agriculture.

(a) If either the Department of Health, Education, and Welfare or the Department of Agriculture exercises its authority to quarantine an extraterrestrially exposed person, property, animal, or other form of life or matter whatever, NASA will, except as provided in paragraph (c) of this section, not exercise the authority to quarantine that same person, property, animal, or other form of life or matter whatever. In such cases, NASA will offer to these departments the use of the Lunar Receiving Laboratory Quarantine Station and such other service, equipment, personnel, and facilities as may be necessary to ensure an effective quarantine.

(b) If neither the Department of Health, Education, and Welfare or the Department of Agriculture exercises its quarantine authority, NASA shall exercise the authority to quarantine an extraterrestrially exposed person, property, animal or other form of life or matter whatever. In such cases, NASA will inform these departments of such quarantine action and, in addition, may request the use of such service, equipment, personnel and facilities of other Federal departments and agencies as may be necessary to ensure an effective quarantine.

§ 1211.105

(c) NASA shall quarantine NASA astronauts and other NASA personnel as determined necessary and all NASA property involved in any space mission.

§ 1211.106 Cooperation with States, territories, and possessions.

Actions taken in accordance with the provisions of this part shall be exercised in cooperation with the applicable authority of any State, territory, possession or any political subdivision thereof.

§ 1211.107 Court or other process.

(a) NASA officers and employees are prohibited from discharging from the limits of a quarantine station any quarantined person, property, animal or other form of life or matter whatever during order or other request, order or demand an announced quarantine period in compliance with a subpoena, show cause of any court or other authority without the prior approval of the General Counsel and the Administrator.

(b) Where approval to discharge a quarantined person, property, animal or other form of life or matter whatever in compliance with such a request, order or demand of any court or other authority is not given, the person to whom it is directed shall, if possible, appear in court or before the other authority and respectfully state his inability to comply, relying for his action upon this § 1211.107.

§ 1211.108 Violations.

Whoever, willfully violates, attempts to violate, or conspires to violate any provision of this part or any regulation or order issued under this part or who enters or departs from the limits of any quarantine station in disregard of the quarantine rules or regulations or without permission of the NASA quarantine officer shall be fined not more than \$5,000 or imprisoned not more than 1 year, or both (18 U.S.C. 799).

Accordingly, the Secretary of the Navy has determined in writing that the public interest requires that all sessions of the meeting be closed to the public because they will be concerned with matters listed in section 552b(c)(1) of title 5, United States Code.

USSR: MEDIA REPORT MULTITUDE OF UFO SIGHTINGS

Leading Soviet newspapers and journals have recently begun publishing an increasing number of articles and news reports on sightings of unidentified flying objects (UFOs) in various areas of the Soviet Union. A "permanent center" for the study of UFOs has been established in Moscow to conduct research and support the investigation of reported sightings.

Setting the tone for this media coverage was an article in the 9 July 1989 SOTSIALISTICHESKAYA INDUSTRIYA, which referred to many recent reports of UFO sightings in the USSR. Interviewed by the paper, P. Prokopenko, director of a laboratory for the study of "anomalous phenomena," stated that a "permanent center" for the study of UFOs is being established in the Soviet Union. In addition to conducting research and presenting lectures on UFOs, the center will support the investigation of reported sightings.

In referring to an issue of the paper published in July 1988 that included a report on "an amazing event that took place on Hill 611 near the village of Dalnegorsk in Primorskiy Kray," the article noted that the event is still under investigation. Many observers saw a flying sphere crash into one of the hill's twin peaks, and physicists and other scientists from the Siberian Division of the USSR Academy of Sciences are still studying the "fine mesh," "small spherical objects," and "pieces of glass" that are considered to be small remnants left behind by the sphere. According to the article, the alleged spacecraft was nearly obliterated in the crash, but there appears to be enough material at the site for the scientists--a mixture of UFO "enthusiasts" and skeptics--to eventually "penetrate this mystery."

In studying the site, scientist A. Makeyev reported finding gold, silver, nickel, alpha-titanium, molybdenum, and compounds of beryllium. One of the "skeptical" physicists from Tomsk has hypothesized that the so-called sphere could have been some kind of a "plasmoid," formed by the "interaction of geophysical force fields," which captured the elements found by Makeyev from the atmosphere on its trajectory toward disintegration on the hilltop. Other researchers have generally rejected this explanation since the amounts of various types of metals found at the site would imply, according to this "plasmoid" theory, that "the concentration of metals in the atmosphere should exceed the present level by a factor of 4,000."

Some of the scientists have concluded that the object that crashed into Hill 611 was an "extraterrestrial" space vehicle constructed by highly intelligent beings. Doctor of Chemical Sciences V. Vysotskiy stated that "without doubt, this is evidence of a high technology, and it is not anything of a natural or terrestrial origin." He cited the fact that the remnants of fine mesh included bits of thin threads with a diameter of only ^{0066"} 17 microns and that these threads, in turn, were composed of even thinner strands twisted into braids. Extremely thin gold wires were discovered intertwined in the finest threads--evidence of an intricate technology beyond the present capabilities of terrestrial science, according to Vysotskiy.

SOTSIALISTICHESKAYA INDUSTRIYA of 25 July 1989 reported that a UFO sighting had been claimed by engineer Yuriy Ponomarenko and a group of workers at a collective farm in the Dnepropetrovsk region². The object was described as a disk with two beams of light emanating from its sides. The witnesses maintained that they had observed the object on the ground for about 20 minutes, and that it emitted no sound when it flew away.

The August 1989 issue of the Soviet journal *NAUKA I ZHIZN* included a 9-page article which, after summarizing the history of UFO sightings in general, contrasted some of the views of the "skeptics" with some of the opinions of the "enthusiasts" on the numerous reported UFO sightings in the USSR, including incidents in Serpukhov, Petrozavodsk, and Rudnya. According to the "enthusiasts," UFOs have left evidence of their visits on many occasions, including the Serpukhov incident in which, they claim, a UFO left a circular depression in the grass with a diameter of 4 meters. The skeptics maintain that most of this so-called "evidence" can be explained as having no connection with extraterrestrial intelligence. Many of the sightings could be attributed to rocket testing, for example. Academician Vladimir Vasilyevich Migulin, director of the Terrestrial Magnetism, Ionosphere, and Radio Wave Propagation Institute in Troitsk, which has a section for the investigation of anomalous phenomena in the atmosphere, maintains that over 90 percent of UFO sightings can be nullified by such mundane explanations.

STROITELNAYA GAZETA of 16 September 1989 reported that in August a group of observers including physical scientist Elvir Kurchenko began investigating another circular depressed area in a forest near Surgut³ after a worker claimed that a UFO had visited the site.

SOTSIALISTICHESKAYA INDUSTRIYA of 30 September 1989 noted that media all over the Soviet Union were receiving reports of UFO sightings on the ground and in the air, adding that the paper's editorial office was reviewing hundreds of reports related to UFO incidents. In response to this deluge of reports, the paper interviewed Anatoliy Listratov, chairman of the section of the All-Union Astronomical and Geodesic Society assigned to the study of anomalous phenomena, who said that although his group is "still wandering around in the darkness," some important developments in the investigations had recently occurred. He stated that "at the sites of the landings...the operating frequency of a crystal-controlled oscillator changes. Simply speaking, electronic timepieces run at rates that are either too fast or too slow."

Listratov noted that Soviet military officers and pilots had recently started providing some documentation on UFO sightings. As an example, he stated that he had documentary information regarding an encounter between Soviet aircraft and a UFO over the city of Borisov⁴. The crews of two

Soviet aircraft reported seeing a large flying disk in their vicinity with five beams of light emanating from it: three beams were directed toward the ground and two were projected upward when the object was first sighted. The ground controller instructed one of the planes to alter its course and approach the object, at which point the disk flew to the same level and aimed one of its beams at the approaching Soviet plane, illuminating the cockpit. Listratov cited the pilot's log as stating: "At this time, the copilot was at the controls. He observed the maneuver that the object had just carried out and was able to raise his hand to shield himself from the unbearable light. The aircraft commander was resting in the adjoining seat, and a bright ray of light, projecting a spot with a diameter of 20 centimeters, passed across his body. Both pilots felt heat."

According to Listratov, the aircraft commander and his copilot both became "invalids" shortly after the incident. The copilot was forced to leave his job due to a sudden deterioration in his health, including the onset of sudden prolonged periods of "loss of consciousness." The aircraft commander died within a few months. The cause of death was listed as "cancer," and "injury to the organism as a result of radiation from an unidentified flying object" was listed as a contributing factor on the official medical record in the hospital where the commander died, according to Listratov.

Listratov told SOTSIALISTICHESKAYA INDUSTRIYA that about 95 percent of UFO sightings could be explained, and investigations have often revealed them to be burned-out rocket stages or the remnants of unsuccessful rocket launches. It is the 5 percent that cannot be explained that is causing all the commotion among Soviet scientists and military personnel. Instead of the widespread skepticism that he had expected when he first began to interview military personnel, he noted that officers and soldiers had told him about their own encounters with UFOs, and they had even shown him reports that had been completely filled out on official forms.

KOMSOMOLSKAYA PRAVDA of 7 October reported that the Soviet Union had just opened an official center for the study of UFOs in Moscow. Physicists, geologists, astronomers, and psychologists are teaching courses on the various characteristics of the UFOs that have been reported and the types of equipment necessary to investigate UFO sightings.

On 9 October the Soviet news agency TASS reported that a UFO had landed in a park in the city of Voronezh. TASS reported that the object had been observed by many witnesses before it left.

KOMSOMOLSKAYA PRAVDA of 12 October reported that a group of scientists had visited a field in Perm Oblast to investigate claims that a UFO had landed in that area and had left behind a circular impression measuring 62 meters in diameter.

KRASNAYA ZVEZDA of 13 October suggested that mass hysteria may be an important factor contributing to the recent outburst of widespread claims of encounters with UFOs in the USSR. According to the paper, many elements of the Soviet media were fanning this phenomenon, which it compared to the hysteria resulting from Orson Welles' radio broadcast in 1938 about an invasion of the United States by extraterrestrials.

The 19-25 October issue of POISK carried an article contrasting the viewpoints of scientists from the two main Soviet institutes presently

engaged in investigating UFO reports--the newly established center for UFO studies in the Palace of Culture of Power Engineers in Moscow and the Terrestrial Magnetism, Ionosphere, and Radio Wave Propagation Institute, which has branches in Troitsk, Leningrad, and Irkutsk. Physicist Yuriy Platov of the Terrestrial Magnetism Institute does not believe the claims of scientists who maintain they have found remnants in Dalnegorsk of a UFO constructed by extraterrestrials, and he is convinced that the materials found at that site are really only the remnants of the unsuccessful launch of a Soviet rocket in that region. He believes that many of the other reports of UFOs can be explained by the inability of the observers to recognize the phenomenon known as "ball lightning."

The POISK article contrasted Platov's view with that of another physical scientist, Vladimir Azhazha, who was recently elected chairman of the new All-Union Commission for the Study of Unidentified Flying Objects of the Union of Scientific and Engineering Societies. Azhazha compared reports of a UFO crash in the USSR with a claim by UFO enthusiasts in the United States that a UFO had crashed in the desert near Roswell, New Mexico, in 1947. He believes there is sufficient evidence to support the claims of UFO crashes in both cases--in Dalnegorsk and in Roswell. In the latter case, he cited the testimony of eyewitnesses who maintained that they had seen the bodies of four extraterrestrials lying near the smashed spacecraft. According to Platov, however, the eyewitnesses in the Roswell case were mistaken. He believes that the object that crashed was a USAF experimental rocket with four Rhesus monkeys aboard and that the accident was the result of an unsuccessful launch attempt at the dawn of the space era.

SOTSIALISTICHESKAYA INDUSTRIYA of 21 October noted that hundreds of residents had reported observing a UFO in Omsk and that many of these eyewitnesses had reported the sighting directly to the paper's office in Omsk. The article included a report by an "authoritative" military officer, Maj V. Loginov, who stated: "I must tell you straight off that radar did not detect this object, and so I am reporting visual observations. The object was passing over at an altitude of several kilometers. The visible shining sphere appeared to be about one and a half times as large as the moon's shape in the night sky. Four projectors--some parallel and some at angles to the Earth--were casting very bright beams. The object was in the field of vision for about 5 minutes...hovering...over the civil airport before descending a little. Then the projectors were turned off and a whirling plume trail instantaneously appeared around this shining sphere. The object began to recede rapidly in a direction from the northwest to the east at the same time that flights were being carried out from a neighboring airport. Pilots were able to observe it visually, but they could not detect it on their radar screens.... Radar signals could not be reflected from it. This object was immediately reported up the chain-of-command, and our colleagues in the Altay Kray, in the area toward which the object flew, reported back to us within 5 minutes that they had it under visual observation. That meant that it had covered a distance of approximately 600 kilometers at a speed of about 7,000 kilometers per hour."

According to Loginov, all observations indicated that the object was a UFO being controlled by some kind of intelligence and that it was not merely some kind of anomalous atmospheric phenomenon.

SOVETSKAYA KULTURA of 28 October reported on the results of a conference in Petrozavodsk of about 100 Soviet scientists representing the "various branches of science and technology." The main topic of discussion was the multitude of claims of recent UFO sightings in the USSR. According to SOVETSKAYA KULTURA, more questions about UFOs were raised at this conference than were answered.

LITERATURNAYA GAZETA of 1 November reported that Voronezh, where some observers had claimed to have witnessed the landing and take-off of a UFO, has become the place for a "pilgrimage" by correspondents seeking sensational news for their newspapers, regardless of the controversial nature of the so-called "weighty evidence" being presented as proof that extraterrestrials had visited Voronezh.

Even though by now it is old news to you, a few nights ago I viewed the "Best Evidence 2" George Knapp tape and was disgusted by the obvious hatchet job Knapp, Lear, Moore et al did on you.

Apparently Pope hired the most erudite, competent reporters he could find, really a blue ribbon staff, and 99% of all the information they uncovered and stories they wrote disappeared into the big computer, inaccessible to everyone including the authors, except Mr. Pope. Pretty slick information-gathering.

I regret to say that at this point it looks as though I will not be able to attend the conference at the end of the month as much as I would like to. Frankly I feel that my presence along with yours is necessary, but finances are an extreme problem at this point. With the medical bills piling up from my wife's recent miscarriage and my stroke, and then the most recent loss of my job, we are extremely lucky not to be forced to live in the car at the moment, and that's a very distinct possibility that looms in the future. I have sold off just about everything except my computer and the few odds and ends that help to keep us going on a day to day basis. Oh well....shit happens.

I am interested in your reaction to Dick Scheffler. Dick is a fairly out spoken person and some what talkative so don't be put off by him. He really is in fact a nice guy, but doesn't really understand the gravity of what is taking place. Even though he says that he does. A word of advice to you when you meet with him. If you don't want to see it in the news don't say it to him. I have had a hell of a time keeping your speeches away from him in order to protect you as you requested. Dick's heart is in the right place however, so don't be to put off by him. He knows very little about what we are doing, but his enthusiasm is genuine.

I was extremely impressed with your most recent speech, and go on record that my research pretty much confirms what yours has. It is interesting that we have managed to keep our collective butts in one piece over the past several years, however that is something that could well be remedied very shortly if we don't take certain precautions. In point of fact a great deal of pressure is being brought to bear on a number of people. Most notably yourself and Bill Steinman. 

At your request I have made a few inquiries regarding the past law enforcement career of Don Ecker. As you indicated, and as I have myself discovered, Mr. Ecker claims to have had ten years in law enforcement as a criminal investigator for the State of Idaho as well as experience with the Canyon County Sheriff's Dept.

First and foremost, my inquiries are not based upon any known infractions of law, but are to confirm or refute a claim of a particular career in law enforcement.


My research has revealed the following:


Donald Francis Ecker II was employed as a prison guard for the State of Idaho from Sept of 1981 through Sept of 1982. In the fall of 1982 he went to work for the Canyon County Sheriff's Department as a Narcotics Officer. This employment as a Narc lasted only six weeks. He then returned to working as a prison guard until July of 1987. His departure from work as a guard is related to an unfortunate training accident in which he discharged a shotgun into his left leg, causing it's loss from the knee down.

A check with other law enforcement agencies as well as the State of Idaho Bureau of Investigation reveals no employment as a criminal investigator at any time. Pertinent cross-referencing of Mr. Ecker's ID verifying information, including his photograph as published alongside magazine articles he authored, were circulated between the Canyon County Sheriff's Dept., the prison, and the Bureau of Investigation. This resulted in positive confirmation that the Don Ecker I researched and the Don Ecker you know are one and the same individual.

I cannot disclose more specific information regarding his employment, such as the reason for the brevity of service with the Sheriff's Dept in Canyon County. However, any competent investigator can easily retrieve this information and much more. Since your request was regarding confirmation or refutation of Mr. Ecker's claims to a past as a criminal investigator, I have limited my report to information that is available to the public sector.

In conclusion, there is apparently no support whatsoever for Mr. Ecker's claim to having been a "criminal investigator for ten years in the State of Idaho."

Thanks for your recent letter.

I think that we could indeed be helpful to each other. My project is now taking me into some very odd areas indeed, and I need all the guidance possible. But more on that later.

First:

UFO, vol. 2, #4 includes an article by Barry Taff, written in conjunction with one Kerry Gaynor, entitled "Paranormal Phenomena and UFOs." The article itself was not nearly so interesting as Taff's resumé: "...he has worked with UCLA's Neuropsychiatric Institute and has acted as a consultant to a number of governmental agencies, including the National Institute of Mental Health, Rand Corporation, The Atomic Energy Commission and the CIA." (Gaynor is described as a "hypnotherapist and UCLA graduate" who has worked with Taff from 1974 to 1980.)

Ohh, gee, [REDACTED]...you actually trust this guy?

Perhaps the *most* ominous connection in that resumé is not to the CIA, but to the UCLA Neuropsychiatric Institute, Dr. Louis Jolyon West's spook-house. You must know of West's covert background -- his work on brainwashing for the CIA, his horrifying Institute For the Study of Violent Behavior, his connection to the V.A. hospital...and that's just the beginning. Info on "Jolly" is tough to come by, but I've got some stuff you won't believe -- especially some very bizarre tidbits ostensibly connecting him to John Lilly. West is a spook and a racist, and he has been involved with all the techniques of *mind control*.

CI interviewed someone who met West socially; he described the good doctor -- and his wife! -- as frightening, peculiar, and very, very strange...almost the stereotypical "mad scientist." The same descriptions keep on popping up whenever I get "personal" information on the spy-psychiatry. You think these guys practice their mind-altering techniques on each other??

band, AEC, HHHH -- you know their histories. Taff is linked to warmongers, covert operators, and brainwasher. The man is bad news, and any exculpatory fables he tells you should be disregarded. If you want my advice, stay away from this guy, even if he claims to offer an inside track on the scoop of the century, and even if his info tends to verify your preconceptions. Please don't take this as an insult, but frankly, the fact that you deal with Taff (and Lear) makes me uneasy dealing with you.

On the other hand... As you know, my main business right now is catching the brainwashers. Taff and Gaynor seem to be possible targets -- their backgrounds make them suspicious to me. Maybe you can help my project by "picking their brains" on the subject of mind control. Ask Taff about the use of microwaves to create auditory phenomena he mentions this effect (the "Frey effect") in his article, and connects it to UFOs. I'd like more information on this topic, but medical references are hard to come by. For God's sake, though -- don't tell Taff what I'm up to!

Additionally, I'd like to get hold of a photograph of Gaynor. One excellent method of playing "spot the spook" might be the trick demonstrated in the film of The Manchurian Candidate -- flashing a series of photographs past the eyes of an alleged brainwashing victim, in the hope that images of certain "doctors" will strike a cord. It's an idea -- if you have any others, please let me know.

About Vicki -- well, thereby hangs a tale, one which has caused me no small amount of personal hurt and sorrow and bewilderment. I've inflicted my angst on everyone I know -- and you'll be no exception, alas; I apologise beforehand for the torrent of spew to come...

Her uncle is Grant Cooper, the attorney for Sirhan Sirhan -- and for the Johnny Roselli mob, which was intricately connected to the CIA. I am sending you photocopies of the relevant pages from Donald Scheim's book, Contract On America. Theodore Charach's film, The Second Gun (released on HFI home video as The Plot to Kill Robert F. Kennedy) contains interviews in which Sirhan's mother curses out her son's attorneys. As you know, they willfully disregarded testimony which could have helped Sirhan's case. Morrow's The Senator Must Die also has useful information. Grant Cooper is as corrupt as they come, in my opinion: While defending Roselli's men, he illegally got hold of the prosecution's list of potential witnesses. (See -- now why would the mob want a thing like that?) *← Actually, it's a bit of a hassle to get the servants made right now -- but this summary should do.*

As you can guess, the fact that Vicki has an uncle like this -- and a friend like Barry Taff -- made me nervous. My

anxiety was not quelled by Vicki's frequent non-sequitor comments about the CIA somehow "pushing" her magazine.

Still, I felt I could trust her because she seemed so gung-ho when it came to exposing intelligence agency abuses. She was attending ARDIS lectures, familiarising herself with the Christie case, reading Prouty, talking to Landis and Stockwell and John Judge -- all very impressive.

But then she changed. Whereas once we exchanged information almost daily, suddenly she grew more distant -- and when we did talk, an odd anti-soviet hysteria entered her dialogue. For example, she suggested (employing a truly unique quasi-logic) that the key to my UFO hypothesis might have to do with the "massive" Soviet infiltration of the media; apparently, the abductions are some sort of dirty red propaganda ploy.

Her tone baffled me -- until I met her new boyfriend, one Don Ecker, ex-Green Beret and foreign-policy "fascist" (Vicki's description -- although later she rather annoyingly pinned the words on me). Ecker and I had a genuinely nauseating conversation. He drunkenly interrupted an important discussion I was having with Richard Neal to inform us all of a project SPETSNAZ (the name rings a bell, but I can't place it exactly) which, in his fantasies, involves a Soviet invasion via the north. He insisted that the odious Pods had already skulked across Alaska and were working their way through Canada! (I'm considering placing a call to Gnome information to ask if they've seen any rampaging bolsheviks lately.) He also laughed at my assertion that Secord and North were involved with the Iran hostage rescue mission. "Looks like you haven't done your research, buddy!" -- he said, before launching into the Soldier-of-Fortune version of the event. (Gee, I guess Coverd Action, The Nation, The Miami Herald, and Mother Jones all got the story wrong.) He went on to praise covert ops fulsomely. He also produced a card -- picturesquely stained with human blood -- bearing cutely rewritten Miranda rights: "You have the right to have your head bashed in," etc.

I tell you all this, not just because the encounter still smacks, but to give you some notion of the extreme-rightist delirium he's no doubt been feeding Vicki. When he upheld the policy of electrically torturing VC prisoners during the war, I flew into a volcanic rage, and spouted out that anyone who did that deserved to be called a baby-burner when he returned to the states. Later, when he relayed my statement to Vicki, he twisted my words to make it seem that I called him a baby-burner personally.

You have to understand my position -- I once had dinner with a political refugee from Chile, who told (and this was the

... sort of monologues that can induce a frightful insomnia in me. Listening to of how he had undergone just this sort of electro-shock torture -- and how the Special Forces played a large part in placing Pinochet in power. So to see this snarling spook Eckert laughing at the idea of "gooks" being "wired up"...well, I gained a new insight into the depths of the human mind that night.

But the worst part was the fact that I could no longer have anything to do with Vicki. I know this decision seems low and foolish -- cutting of a friendship because I'm appalled at her choice of romantic leads. Honest, I wanted her to be happy; -- I could sense, previously, that she was a lonely woman, and when she first told me about this fellow, I encouraged her to see him, despite her initial qualms. (Indeed, I might be said to have helped bring them together -- this was before I learned what he was, mind you...) But above all, I wanted Vicki to stay Vicki.

Now I feel betrayed. Vicki and I had, after all, worked quite closely together -- and we were going after the "gooks". For that sort of project, you need partners of like mind when it comes to matters political. Then she hops into bed with (for all intents and purposes) the CIA itself! (You know about Special Forces connections with the Company, the Nazis, Lootian drug smuggling, Jonestown, etc.) Suddenly, Vicki changed from Helen Caldicott to Phyllis Theloff, from an ARDIS attendee to an interested guest at the official ex-spook organisation. Suddenly, she calls me a fanatic. (She also calls her boyfriend a fascist -- apparently, fascism isn't fanaticism.)

Because she presented such an unprecedented case of political elasticity, I wondered if she was a spook. To tell the truth, for a week or three, I was certain of it. My disposition wasn't helped when I learned she was talking behind my back to an abductee -- [REDACTED] -- with whom I've worked closely; Vicki told [REDACTED] that I was a KGB agent and should be avoided! -- Obviously, by this stage, the accusations and counter-accusations reach a level of absurdity. At least my accusations, however fueled by suspicion and hurt feelings, come weighted with some evidence, and are directed toward the accused. Vicki, by comparison, has constantly spread catty "agent" rumours, unconfirmed by any data, behind the backs of every major figure on the UFO scene. -- You included.

To tell me, now that you know all the sordid details -- what am I to think? Was she spying on me all along? Or should I chalk this whole incident up to a painful lesson in the vagaries of human relations? The whole matter is infinitely confusing, but I know one thing -- I lost a friend, and it stung.

APPENDIX C: ALIEN IMPLANTS

In one method, the individual is made to don a helmet covered with wires, and a crystalline cubic affair is put into a niche in the top of the helmet and a strobe light is made to play on the individual's optic nerve in order to entrain patterns onto their brain waves.

The recipient's initial reaction is that his consciousness is aware of scrambled images, which - after the initial shock wears off - are aligned sequentially and impressed into his consciousness.

In short, the person is given a programmed response system. In this way individuals are trained in a brief time to do complex tasks without having to undergo lengthy training.

Sometimes the subject is hypnotized or made to sleep and a high frequency microwave emission is used as a carrier wave on which to transmit encoded data into the nerve complex. This information may be triggered into conscious awareness at a later time by a preset stimulus-response signal in the environment, such as a sub-audio or visual signal. It might be noted here that not only do different alien groups use this technique, but modifications of this technique are used by [REDACTED]

Many of the [REDACTED] in the United States were carried out in this manner. There are innumerable references to support that statement.

The carrier waves are usually emanations that will parallel the biological field frequency of the entity itself, or resonate upon it.

They are often sound-code symbols or visuals in facsimile form.

The Grey Species 2 (Reticulans) have an interesting variation in technique whereby the recipient sits fully aware facing a screen and computer console and interacts with images on a holographic display.

It is thought that the events during the Bentwaters incident in 1980 that took place underground to one of the military members was one of these processes. The subject was put before a similar screen, and even though there were others in chairs in the room, the screen was addressing him as an individual.

There is another process which occurs which involves the recipient lying on a table (or being suspended in the air) facing upwards where they can view a light bar of multi-colored flashing lights. It is here where billion-year-old psychological implants may be restimulated.

Some of these implants are responsible for humans not realizing their true nature and also for the system of self-imposed limitation that is rampant on earth. During this process, the recipient is re-programmed to perform other activities which can be triggered at a later moment. There is some evidence that many abductees over the past several years have been programmed with instructions, but we cannot determine the exact nature of the instructions - only that they are to be carried out in the next two to five years.

While these interactions serve to slow the evolution of humans, they do not bring anything to a halt. The Grey species in general will only gain a temporary interactive benefit from these actions, and eventually all Grey species will cease this type of interaction and will progress to other activities.

An ID tag that won't get lost

When Tammy Adin of Novato found two collars half-buried in a muddy hole under her backyard fence, her heart dropped. Both of her dogs, Sandy, a five-year-old Shepherd mix and Buddy Holly, recently adopted from the Marin Humane Society, had dug a hole under the fence, squirming out of their collars in the process, and headed for the hills.

Adin searched everywhere, placed lost dog posters throughout the county, checked with the Marin and Sonoma Humane Societies every day, and even hired a private eye for pets to help track them down. After five days, Sandy showed up on his own, his pads bloody and worn. But Buddy Holly was nowhere to be found.

A few days later, a couple of hikers found a stray miniature pinscher roaming aimlessly on a fire road in the Novato hills. They brought the frightened dog to the shelter, where he was routinely scanned with an Infotag scanner. At the sound of a beep, a 10-digit number appeared on a screen identifying the dog as Buddy Holly.

For nearly a year, the Marin Humane Society has been implanting every dog and cat adopted from the shelter with an Infotag microchip I.D., a high-tech answer to the age-old problem of permanently identifying your beloved pet.

The microchip, about the size of an uncooked grain of rice, is encased in biomedical grade glass. The chip is imprinted with a ten-digit alpha-numeric code and is implanted with a ten-digit alpha-numeric code and is implanted with simple injection between the animal's shoulder blades. With the wave of a hand-held scanner, the chip is activated to transmit the code to a computer which provides the owner's name and address, any relevant medical information and, most importantly, the owner's phone number.

Since May, the Marin Humane Society has recovered 16 animals with microchip I.D.'s. Some of the animals had no other form of identification, despite the fact that a few were wearing collars with both license and I.D. tags before being reported missing.

Thomas Fortmuller credits his brother-in-law, a Fremont veterinarian, and the Marin Humane Society with reuniting him with his cat, Meitzi, who wandered off while he was on a job site in Sausalito. If it weren't for the microchip implanted in Meitzi just days before she ran away, Fortmuller doubts she would be alive today.

"I kept thinking Meitzi would turn up on her own," said Fortmuller, "You know how cats are." Unfortunately, shelters are all too familiar with the fact that people do not place I.D. tags on their cats and do not make a "dogged" effort to search for them when they are missing. In 1989 alone, 2,146 lost cats waited at the Marin shelter for owners who never came.

"It's a tragedy," says Humane Society executive director Diane Allevalo. "While the percentage of dogs that are returned to their owners is nearly 80 percent at our shelter, the redemption rate for cats ranges from an abysmal 7 to 20 percent."

In the year and a half since Infotag began offering the service, 10,000 pets have been microtagged in California, Oregon, Missouri, Massachusetts, Arizona and Canada.

In California, 160 veterinarians are currently implanting microchips for their clients' pets. Marin veterinarians who offer the service are Bel Marin Animal Hospital; Madera Hospital; the Marin Humane Society Spay and Neuter Clinic; Northbay Animal Hospital and Tamalpais Pet Hospital, Inc.

The microchip, its insertion and a year of registration cost \$40. A small price to pay, according to Liz Greenberg of Ignacio. Greenberg, whose purebred golden retriever, Beau, was purchased from a breeder for more than \$500, decided to have Beau microtagged so that if he were to end up at the shelter without his collar, the Humane Society would know who to call.

Greenberg's instincts were proven right last September when Beau turned up at the shelter. "I'm very glad that I did it," said Greenberg, "It's really a silly thing not to do."

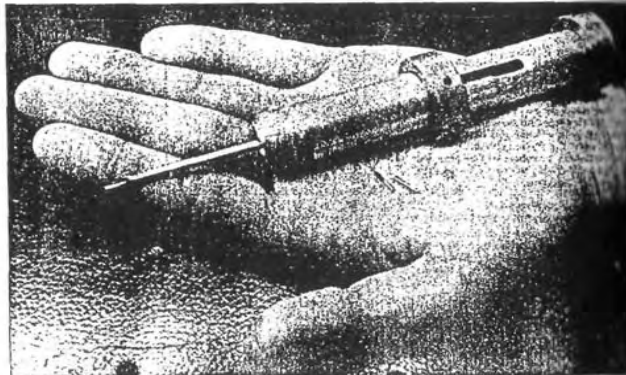
would have to do is make up something like the swine flu vaccine," Milgram says.

And over 2000 young white male homosexuals (Trojan horse) in 1978 with the hepatitis B vaccine through the Centers for Disease Control/New York Blood Center. SYNTHETIC BIOLOGICAL AGENTS

There are two things about the biological agent field I would like to mention. One is the possibility of technological surprise. Molecular biology is a field that is advancing very rapidly and eminent biologists believe that within a period of 5 to 10 years it would be possible to produce a synthetic biological agent, an agent that does not naturally exist and for which no natural immunity could have been acquired.

Mr. SIKES. Are we doing any work in that field?

Dr. MACARTHUR. We are not.

Mr. SIKES. Why not? Lack of money or lack of interest?

Dr. MACARTHUR. Certainly not lack of interest.

Mr. SIKES. Would you provide for our records information on what would be required, what the advantages of such a program would be, the time and the cost involved?

Dr. MACARTHUR. We will be very happy to.

(The information follows:)

The dramatic progress being made in the field of molecular biology led us to investigate the relevance of this field of science to biological warfare. A small group of experts considered this matter and provided the following observations:

1. All biological agents up to the present time are representatives of naturally occurring disease, and are thus known by scientists throughout the world. They are easily available to qualified scientists for research, either for offensive or defensive purposes.
 - * 2. Within the next 5 to 10 years, it would probably be possible to make a new infective microorganism which could differ in certain important aspects from any known disease-causing organisms. Most important of these is that it might be refractory to the immunological and therapeutic processes upon which we depend to maintain our relative freedom from infectious disease.
 - * 3. A research program to explore the feasibility of this could be completed in approximately 5 years at a total cost of \$10 million.
 4. It would be very difficult to establish such a program. Molecular biology is a relatively new science. There are not many highly competent scientists in the field, almost all are in university laboratories, and they are generally adequately supported from sources other than DOD. However, it was considered possible to initiate an adequate program through the National Academy of Sciences-National Research Council (NAS-NRC).
- The matter was discussed with the NAS-NRC, and tentative plans were made to initiate the program. However, decreasing funds in CB, growing criticism of the CB program, and our reluctance to involve the NAS NRC in such a controversial endeavor have led us to postpone it for the past 2 years.
- * It is a highly controversial issue and there are many who believe such research should not be undertaken lest it lead to yet another method of massive killing of large populations. On the other hand, without the sure scientific knowledge that such a weapon is possible, and an understanding of the ways it could be done, there is little that can be done to devise defensive measures. Should an enemy develop it there is little doubt that this is an important area of potential military technological inferiority in which there is no adequate research program.

AIDS Taking Heavy Toll of Children

Acquired immune deficiency syndrome is striking many more children than previously thought, the World Health Organization reported. The U.N. agency said in Geneva that the HIV virus that causes AIDS will probably infect 10 million children by the year 2000. Already about 400,000 cases, or a third of the 1.2 million estimated cases of AIDS worldwide to date, are believed to have occurred in children under age 5.

I'm confused. Are we to believe that these 400,000 children are practicing homosexuals or IV drug users? Or that $\approx 400,000$ ($\frac{1}{3}$) of their mothers transmit the disease? Or is it more likely that they are neither part of the high-risk group nor born of mothers with AIDS (meaning, of course, that $\frac{1}{3}$ babes + $\frac{1}{3}$ moms = $\frac{2}{3}$ of total AIDS population... no one is making this claim!) These data, if valid, come close to proving that AIDS is transmissible by casual contact and/or insects.

1. Motivation and Objectives

The world problematique formulated by the CLUB OF ROME is not only global in nature, involving factors traditionally considered as unrelated, but also points to the crisis situations which are developing in spite of the noblest of intentions and, indeed, as their corollary. To point out the problematique and the spectrum of critical and traumatic situations it entails is not enough; the acceptance of the reality of the problematique MUST BE FOLLOWED BY CHANGES IF THE CONCERN IS NOT TO REMAIN PURELY ACADEMIC. It is necessary, therefore, to present the issues within the problematique in specific and relevant terms which requires regions interpretation of the global issues. Furthermore, a basis should be provided for the resolution of conflicts (inevitably accompanying the problematique-type situations) through cooperation rather than confrontation. These factors have provided the motivation for initiation of the Strategy for Survival project which calls for the construction of a regionalized and adaptive model of the total world system with the following specific objectives:

(i) TO ENABLE THE IMPLEMENTATION OF SCENARIOS FOR THE FUTURE DEVELOPMENT OF THE WORLD SYSTEM which represent visions of the world future stemming from different cultures and value systems and reflecting hopes and fears in different regions of the world.

(ii) To develop a planning and options-assessment tool for long-range issues, and thereby TO PROVIDE A BASIS FOR CONFLICT RESOLUTION by cooperation rather than confrontation.

2. Basic Structure of the Model

The basic characteristics of the model are:

(i) THE WORLD SYSTEM IS REPRESENTED in terms of interacting regions with provisions made to investigate any individual country or subregion in the context of regional and global development. Presently the world system is represented BY TEN REGIONS: NORTH AMERICA, WESTERN EUROPE, EASTERN EUROPE, JAPAN, REST OF DEVELOPED WORLD, LATIN AMERICA, MIDDLE EAST, REST OF AFRICA, SOUTH AND SOUTH EAST ASIA, AND CHINA.

(ii) In order to be able to deal with the complex of factors involved in problematique in a way which is sound, credible and systematic, a hierarchical structure has been adopted for the model in which each level in the hierarchy represents the evolution of the world system within a context defined by a given set of laws and principles. Specifically, the levels involved are:

GEO-PHYSICAL, ECOLOGICAL, TECHNOLOGICAL (MAN-MADE ENERGY AND MASS TRANSFERS), ECONOMIC, INSTITUTIONAL, SOCIO-POLITICAL, VALUE-CULTURAL AND HUMAN-BIOLOGICAL. Such an approach enables an optimal use of confirmed scientific knowledge and available data,

(iii) An adequate view of the conditions in which the problematique is emerging and under which the solutions must be found require the recognition of the purposive aspects of the human community and adaptiveness of human beings. The model of the world system will have, therefore, two parts:

(1) the so-called causal part, representing dynamical processes which follow historical patterns of development and (2) the so-called goal-seeking part which represents purposive changes under new conditions. The goal-seeking part in turn includes two

levels: the decision-making or actions level and the norms level; the former represents the purposive response of the system while the latter represents the values and norms which constrain and condition such a response.

3. Progress in the Model Construction

The construction of the model as described in Sec. 2 and with the objectives as specified in Sec. 1 is certainly a rather complex task and the research is organized to proceed in parallel in several directions. The overall assessment of the model status is the following:

The model has been developed up to the stage where it can be used for policy analysis related to a number of critical issues, such as: energy resources utilization and technology assessment; food demand and production; population growth and the affect of timing of birth control programs; reduction of inequities in regional economic developments; depletion dynamics of certain resources, particularly oil reserves; phosphorus use as fertilizer; regional unemployment; constraints on growth due to labor, energy or export limitation, etc.

Specific developments which enable use of the model as described above include the following:

1. A COMPUTER MODEL OF THE WORLD ECONOMIC SYSTEM HAS BEEN DEVELOPED AND VALIDATED BY AN EXTENSIVE SET OF DATA. The model has two levels - macro and micro. On the MACRO LEVEL the model of each region INCLUDES THE GROSS REGIONAL PRODUCT, TOTAL IMPORTS AND EXPORTS, CAPITAL AND LABOR PRODUCTIVITY AND VARIOUS COMPONENTS OF FINAL DEMAND SUCH AS PUBLIC CONSUMPTION, GOVERNMENT EXPENDITURE, AND TOTAL INVESTMENT. ON THE MICRO LEVEL EIGHT PRODUCTION SECTORS ARE RECOGNIZED: AGRICULTURE MANUFACTURING, FOOD PROCESSING, ENERGY, MINING, SERVICES, BANKING AND TRADE, AND RESIDENTIAL CONSTRUCTION. The input-output framework is used for the intermediate demands. A FULL SCALE MICRO TRADE MATRIX ALSO HAS BEEN DEVELOPED.

2. A WORLD POPULATION MODEL HAS BEEN CONSTRUCTED IN TERMS OF THE SAME REGIONS AS THE ECONOMIC MODEL. The model has been validated by the data available. In each region the population structure is represented in terms of four age groups with appropriate delays which make possible assessment of population momentum and assessment of the effectiveness of implementation of various population control measures.

3. AN ENERGY MODEL HAS BEEN CONSTRUCTED which gives for each region the consumption and production of energy and interregional exchange of energy resources as a function of economic factors. Energy is treated both in composite terms and in reference to individual energy sources, namely solid fuel, liquid fuel, nuclear, gas and hydro.

4. A FOOD PRODUCTION AND ARABLE LAND USE MODEL HAS BEEN CONSTRUCTED which allows the assessment of a number of food related issues including: the need and availability of phosphorus required for intensive agriculture, AND THE CONSEQUENCES OF TIMING AND MAGNITUDES OF NATURAL DISASTERS SUCH AS DROUGHT, CROP FAILURE DUE TO DISEASE, ETC.

5. A MAJOR CONCERN IN THE APPLICATION OF THE COMPUTER MODEL is its proper utilization so as to avoid dependence on the deterministic aspects of model operation. In order to avoid this an interactive method of computer simulation analysis has been developed. THE METHOD REPRESENTS A SYMBIOSIS OF MAN AND COMPUTER IN WHICH THE COMPUTER PROVIDES THE LOGICAL AND NUMERICAL CAPABILITY WHILE MAN PROVIDES THE VALUES, INTUITION AND EXPERIENCE. The method utilizes an option specification and selection program which enables the policy analyst or decision-maker to evaluate alternative options on various levels of the decision process, i.e., with respect to goals, strategies, tactical and implementational factors. SPECIAL ATTENTION IS PAID TO THE NORM CHANGING PROCESSES.

4. Progress in Application

THE MODEL HAS BEEN USED both for the assessment of alternative scenarios for future regional and global developments (under different regional conditions) as well as in the interactive mode selection of policy options (specifically for the energy crises issues in developed regions).

OUR EFFORTS IN THE IMMEDIATE FUTURE WILL BE CONCENTRATED ON FURTHER USE OF THE ALREADY DEVELOPED MODEL. THE PLANS INCLUDE EMPHASIS IN THE FOLLOWING THREE DIRECTIONS:

- (i) Assessment in the changes over time of the span of options available to solve some major crisis problems.
- (ii) IMPLEMENTATION of the regional models in different parts of the world and their connection via a satellite communication network for the purpose of joint assessment of the long term global future by teams from the various regions.
- (iii) Implementation of the vision for the future outlined by leaders from an underdeveloped region in order TO ASSESS with the model EXISTING OBSTACLES AND THE MEANS WHEREBY THE VISION MIGHT BECOME REALITY.

From 1972 to 1974, I was stationed at Clark Air Base, Philippines. During that time, when it appeared that then President Richard M. Nixon might be impeached by Congress, the Base Commander received a message from the Chief of the Joint Chiefs of Staff, Washington, D.C. This message was, at least in part, reprinted in our daily base information publication, THE DAILY BULLETIN. The portion published in THE DAILY BULLETIN stated that any messages received by any base personnel directly from the White House, Washington, D.C. were to be reported directly to the Base Commander immediately. Additionally, the contents of these messages were to be ignored unless they were countersigned by the Chief of the Joint Chiefs of Staff and issued through the Base Commander's Office. I discussed this item with several of the people with whom I worked at the time. The people I can remember are:

Staff Sergeant David Kasper
Staff Sergeant Leah Aasen
Mr. Conrado Barrera (Civilian Employee)
Ms. Mercedes Grepo (Civilian Employee)

I recall that the reason this article was so interesting was that some of us were trying to determine whether we believed that President Nixon would resign rather than face possible impeachment. This was a very popular topic on the base among people with whom I associated. Since no orders from the White House were ever received, as far as I know, nothing more ever came of it.

I hereby declare that I make this statement freely without any reservations and that it is the entire account of this incident according to my memory and belief. I make this statement and declare that it is a true account under the penalty of perjury.

though not yet expressly put forth, is the development of a long-range sequence of space-research projects with largely unattainable goals. This kind of program offers several advantages lacking in the social welfare model. First, it is unlikely to phase itself out, regardless of the predictable "surprises" science has in store for us: the universe is too big. In the event some individual project unexpectedly succeeds there would be no dearth of substitute problems. For example, if colonization of the moon proceeds on schedule, it could then become "necessary" to establish a beachhead on Mars or Jupiter, and so on. Second, it need be no more dependent on the general supply-demand economy than its military prototype. Third, it lends itself extraordinarily well to arbitrary control.

Space research can be viewed as the nearest modern equivalent yet devised to the pyramid-building, and similar ritualistic enterprises, of ancient societies. It is true that the scientific value of the space program, even of what has already been accomplished, is substantial on its own terms. But current programs are absurdly and obviously disproportionate, in the relationship of the knowledge sought to the expenditures committed. All but a small fraction of the space budget, measured by the standards of comparable scientific objectives, must be charged de facto to the military economy. Future space research, projected as a war surrogate, would further reduce the "scientific" rationale of its budget to a minuscule percentage indeed. As a purely economic

substitute for war, therefore, extension of the space program warrants serious consideration.

In Section 3 we pointed out that certain disarmament models, which we called conservative, postulated extremely expensive and elaborate inspection systems. Would it be possible to extend and institutionalize such systems to the point where they might serve as economic surrogates for war spending? The organization of fail-safe inspection machinery could well be ritualized in a manner similar to that of established military processes. "Inspection teams" might be very like armies, and their technical equipment might be very like weapons. Inflating the inspection budget to military scale presents no difficulty. The appeal of this kind of scheme lies in the comparative ease of transition between two parallel systems.

The "elaborate inspection" surrogate is fundamentally fallacious, however. Although it might be economically useful, as well as politically necessary, during the disarmament transition, it would fail as a substitute for the economic function of war for one simple reason. Peace-keeping inspection is part of a war system, not of a peace system. It implies the possibility of weapons maintenance or manufacture, which could not exist in a world at peace as here defined. Massive inspection also implies sanctions, and thus war-readiness.

The same fallacy is more obvious in plans to create a patently useless "defense conversion" apparatus. The long-discredited proposal to build "total" civil defense

obvious destabilizing effect of any global social welfare surrogate on politically necessary class relationships would create an entirely new set of transition problems at least equal in magnitude.

Credibility, in fact, lies at the heart of the problem of developing a political substitute for war. This is where the space-race proposals, in many ways so well suited as economic substitutes for war, fall short. The most ambitious and unrealistic space project cannot of itself generate a believable external menace. It has been hotly argued⁶ that such a menace would offer the "last, best hope of peace," etc., by uniting mankind against the danger of destruction by "creatures" from other planets or from outer space. Experiments have been proposed to test the credibility of an out-of-our-world invasion threat; it is possible that a few of the more difficult-to-explain "flying saucer" incidents of recent years were in fact early experiments of this kind. If so, they could hardly have been judged encouraging. We anticipate no difficulties in making a "need" for a giant super space program credible for economic purposes, even were there not ample precedent; extending it, for political purposes, to include features unfortunately associated with science fiction would obviously be a more dubious undertaking.

Nevertheless, an effective political substitute for war would require "alternate enemies," some of which might seem equally farfetched in the context of the current war system. It may be, for instance, that gross pollution of the environment can eventually replace the possibility of mass destruction by nuclear weapons as the principal

apparent threat to the survival of the species. Poisoning of the air, and of the principal sources of food and water supply, is already well advanced, and at first glance would seem promising in this respect; it constitutes a threat that can be dealt with only through social organization and political power. But from present indications it will be a generation to a generation and a half before environmental pollution, however severe, will be sufficiently menacing, on a global scale, to offer a possible basis for a solution.

It is true that the rate of pollution could be increased selectively for this purpose; in fact, the mere modifying of existing programs for the deterrence of pollution could speed up the process enough to make the threat credible much sooner. But the pollution problem has been so widely publicized in recent years that it seems highly improbable that a program of deliberate environmental poisoning could be implemented in a politically acceptable manner.

However unlikely some of the possible alternate enemies we have mentioned may seem, we must emphasize that one must be found, of credible quality and magnitude, if a transition to peace is ever to come about without social disintegration. It is more probable, in our judgment, that such a threat will have to be invented, rather than developed from unknown conditions. For this reason, we believe further speculation about its putative nature ill-advised in this context. Since there is considerable doubt, in our minds, that any viable political surrogate can be devised, we are reluctant to com-

of the United States as to Central and South America and the enunciation of Japan's attitude toward China. In the first there is on the part of the United States no engagement or promise, while in the other Japan voluntarily announces that Japan will herself engage not to violate the political or territorial integrity of her neighbor, and to observe the principle of the open door and equal opportunity, asking at the same time other nations to respect these principles.

Therefore, gentlemen, you will mark the wide difference and agree with me, I am sure, that the use of the term is somewhat loose and misleading. I ask you to note this with no suggestion that I can or any one else does question the policy or attitude of your country, which we well know will always deal fairly and honorably with other nations.

As you must have noticed, I have persistently struck one note every time I have spoken. It has been the note of warning against German intrigue in America and in Japan—intrigue which has extended over a period of more than ten years. I am not going to weary you with a repetition of this squalid story of plots, conceived and fostered by the agents of Germany, but I solemnly repeat the warning here in this most distinguished gathering, so thoroughly representative of the highest ideals of American journalism.

In my speeches at various places I have endeavored to speak frankly on all points at issue or of interest at this time. There are, of course, some things which can not be openly discussed, because of a wise embargo upon unwise disclosures, but I am confident that from this time forward we will be able to effectively cooperate in all matters tending to secure a victory in this struggle which means so much for all of us, and that throughout all the years to come, differences of opinion or difficulties arising between our two countries will be settled, as all such questions and difficulties can be settled, between close friends and partners.

I thank you, sir, for your hospitality and for your courtesy. I assure you, gentlemen, again that we appreciate more than I can express the high consideration, the patriotism, and the broad and friendly spirit with which you have treated this Mission from Japan.

Comptroller William A. Prendergast was next called upon. He said in part:

Mr. Chairman, Viscount Ishii, gentlemen of the Commission, Your Excellency, and gentlemen: Our host has asked me to say a word of welcome to Viscount Ishii and associate members of the Commission in the name of the great city of New York.

It would seem to me that it is hardly necessary even to attempt to repeat the very great pleasure and honor and happiness that it gives New York to have you as its guests.

Now, Viscount Ishii, might I at this time sound a note which may be somewhat contrary to that which has been the dominant idea of our discussions upon these occasions? We have treated, and naturally, of war. That is the thought that is uppermost in our minds. It is the thing that is in the thought tad the mind of man, woman, and child—war. I can say

detestable war, because war is detestable, and we are fighting this war today for the purpose of driving out war permanently. That is the great object of our entering this war, or one of the great objects, and I am sure that it is also one of yours. It was a great relief to us—a great relief to the civilized world—that when this war broke out you were in your position of primacy upon the Pacific, there to guard effectively and effectually against the diplomatic depredations that might have taken place if Germany had been permitted to do as she was disposed to do in China. For the service that you rendered in that respect the world is indeed your debtor. But the idea that I think we should also have in mind, as well as winning the war, as well as prosecuting it to a successful finish, is this: While we are engaged in this war, let us realize the ties that bind. Let us realize that brothers in war should be brothers in peace; that what we have at interest in the war we will also have at interest in times of peace; and during this struggle, when we are so close together, when we are fraternizing, as brothers should, when we are feeling toward each other as brothers should, let us lay the groundwork of a great commercial relation that no contingency or exigency will ever disturb in the future, the groundwork of a commercial relation that will draw us so close together that we will realize the genuine ties of brotherhood. That, I think, is one of the great desires of the American people, and that is one of the great desires that New York expresses to you, at the conclusion of your happy visit to us.

John Dewey, Professor of Philosophy in Columbia University, who was the next speaker, was listened to with great intencness. He said:

- A { Some one remarked that the best way to unite all the nations on this globe would be an attack from some other planet. In the face of such an alien enemy, people would respond with a sense of their unity of interest and purpose. We have the next thing to that at the present time. Before a common menace, North and South America, the Occident and Orient have done an unheard of thing, a wonderful thing, a thing which, it may well be, future history will point to as the most significant thing in these days of wonderful happenings. They have joined forces amply and intimately in a common cause with one another and with the European nations which were most directly threatened. What a few dreamers hoped might happen in the course of some slow coming century has become an accomplished fact in a few swift years. In spite of geographical distance, unlike speech, diverse religion, and hitherto independent aims, nations from every continent have formed what for the time being is nothing less than a world state, an immense cooperative action in behalf of civilization.
- B. It is safe to say that, with all its preparedness, Germany never anticipated *this* result. Even now the fact is so close to us that even we, who have been brought together, are too much engaged in the duties which the union imposes to realize the force of the new and unique creation of a union of peoples, yes, of continents. The imagination is not yet capable of taking it in.
- C. It has been more than once noted that Germany has exhibited an ex-

traordinary spectacle to the world. It has stood for organization at home and disorganization abroad, for cooperative effort among its own people and for division and hostility among all other peoples. All through the earlier years of the war the intellectuals of Germany appealed for sympathy in this country because of what Germany had done in the way of social legislation and administration to promote the unity of all classes, because of its efficiency in organization, because of the intelligent efforts it had made to secure domestic prosperity. But, at the same time, as events have since only too clearly demonstrated, it was bending every energy of corrupt and hateful intrigue to disunite the American people among themselves and to incite suspicion, jealousy, envy, and even active hostility between the American nation and other nations, like Mexico and Japan, with whom we had every reason to live in amity and no reasons of weight for anything but amity. In the light of this exhibition, German love of organization and cooperative unity at home gains a sinister meaning. It stands convicted of falsity because born of a malicious conspiracy against the rest of the world. It loved unity and harmony, not for themselves, but simply as a means of bringing about that dominion of Germany over the world of which its remorseless and treacherous efforts to divide other peoples are the other half.

The rest of the world, of the once neutral world, was, it must be confessed, slow to awake to Germany's plots and purposes. They seemed fantastic, unreal, in their unbridled lust for power and their incredibly bad faith. It was especially hard for us in this country, who have never been trained to identify our loyalty to our own country with hatred of any other, to realize that Germany's genius for efficiency and organization had become a menace to domestic union and international friendliness over the world. But finally in North America, as in South America, and in Asia, when the case became too clear for further doubt, Germany's challenge was met. Against Germany's efforts to disunite there arose a world united in endeavor and achievement on a scale unprecedented in the history of this globe, a scale too vast not to endure and in enduring to make the future history of international relationships something very different from their past history. In struggling by cunning and corruption to separate and divide other peoples, Germany has succeeded in drawing them together with a rapidity and an intimacy almost beyond belief. Nations thus brought together in community of feeling and action will not easily fall apart, even though the occasion which brought them together passes, as, pray God, it will soon pass. The Germany which seems finally to be breaking up within has furnished the rest of the world with a cement whose uses will not easily be forgotten.

Formal alliances, set treaties, legal arrangements for arbitration and conciliation, leagues and courts of nations, all have their importance. But, gentlemen, their importance is secondary. They are effects rather than causes, symptoms rather than forces. You may have them all, and if nations have not discovered that their permanent interests are in mutuality and interchange, they will be evaded or overridden. They may be lacking, but if the vital sap of reciprocal trust and friendly intercourse is flowing through the arteries of commerce and the public press, they will come in due season

as naturally and inevitably as the trees put forth their leaves when their day of spring has come. It is our problem and our duty, I repeat, especially of you gentlemen of diplomacy and of what I shall venture to call the even more powerful instrument of good will and understanding, the public press, to turn our immediate and temporary relation for purposes of war into an enduring and solid connection for all of the sweet and constructive offices of that peace which must some day again dawn upon a wracked and troubled world. E-

Where diversity is greatest, there is the greatest opportunity for a fruitful cooperation which will be magnificently helpful to those who cooperate. This meeting this evening is a signal evidence of the coming together of the portions of the earth which for countless centuries went their own way in isolation, developing great civilizations, each in their own way. Now in the fulness of days, the Orient and the Occident, the United States and Japan, have drawn together to engage in faith in themselves and in each other in the work of building up a society of nations each free to develop its own national life and each bound in helpful intercourse with every other. May every influence which would sow suspicion and misunderstanding be accursed, and every kindly power that furthers enduring understanding and reciprocal usefulness be blest. May this meeting stand not only as a passing symbol, but as a lasting landmark of the truth that among nations as among men of good will there shall be peace, not a peace of isolation or bare toleration which has become impossible in this round world of ours, not a peace based on mutual fear and mutual armament, but a virile peace in which emulation in commerce, science, and the arts bespeaks two great nations that respect each other because they respect themselves.

Don C. Seitz, of the *New York World*, who has traveled in the Far East and studied its problems, caught the entire attention of the company as he responded to Mr. Villard's call:

I think the visit of the Japanese Commission has been the most impressive among all of those who have come to us from the other parts of the world as the outcome of the great war, and I think, too, it has a great purpose, and is bound to have a great result, because, if you will recall carefully, you will find that the other gentlemen all came to the United States to get something; but these gentlemen have come to give us something.

There is a great deal to be learned in the Orient, and I know it is a trite phrase to say that everything is upside down in the East, that all Oriental ideas are opposite those held by ourselves, but in some ways this is an improvement. There is also a perspicacity among Orientals which we lack ourselves. Only recently I had to sit for nearly an hour and listen to the efforts of a former Attorney General of the United States to explain and vindicate the Monroe Doctrine, and here Viscount Ishii, in the midst of many affairs, sizes it up in a few words, perceiving that our fundamental doctrine is that we will allow no one to lick our neighbors but ourselves.

The East has often been advertised as changeless. This is wrong.

APPENDIX F: U.S. GOVERNMENT DRUG INVOLVEMENT

I have stated again and again since 1984, that George Bush and others close to him, including the so-called "Pink Team" have been involved directly in the cocaine drug trade from Central America. In HOPE'S HUSBAND, I named the CIA-owned Costa Rican Corporations directly involved in this drug trade, using shrimp fishing boats with the cocaine frozen in with the shrimp. I had often wondered where George Bush, and his relatives and friends, would be putting so much money for their own personal profit.

It would be hard to stash it in the United States banks, as someone who is unfriendly to them might leak the information. Well, as most sophisticated investors and financial people know, Panama was one of the best tax haven jurisdictions in the world prior to December 20, 1989. George Bush, with his friendship with Noriega assuring his privacy in financial affairs, would have left his millions in illegal drug profits right there in Panama both in secret bank accounts and in business and tourist properties.

We also know from the NEW YORK TIMES front page story of 2/6/90, by reporter Stephen Labaton, that in spite of the invasion supposedly to stop the international drug trade, Panama is not going to reveal those huge cash deposits in Panama banks, even when allegedly pressured to do so by the United States. Thus we see that Noriega's friends are still in full control in Panama.

Noriega's #1 economic advisor was Carlos Whitgreen. He "fled the country" and is somewhere in Western Europe according to my personal informant in Panama. Personally, I think Carlos has been given another assignment.

Senator John Kerry, (D Mass) has held extensive hearings into the money laundering and the use of Panamanian Banks for drug operations stated in the NEW YORK TIMES that he is "very concerned about it." However, he does not intend to do anything about it. Remember back in 1988 when the U.S. imposed economic sanctions in Panama to halt this money laundering? Well, after these 26 men gave their lives during the Panama Invasion, and Noriega is safely silenced, these sanctions have been suddenly cancelled!

If the invasion was really to stop drug trafficking as well as illegal money laundering, the sanctions would have been increased not reduced. Yet, as of March 26th, the U.S. has released \$480 million in funds which were frozen while Noriega was in power.

American law-enforcement officials said they had evidence that Panamanian banks were used in laundering. In a recent interview, President Endara acknowledged that the success of Panama's financial center in

J.S. Aid package. We have a hunch that some of this money is to protect the Bush Family investments in Panama, and to make the Panama tourist trade again popular so that the Bush string of hotels and resorts will start to make money as planned.

The George Bush hand-picked new President of Panama is Guillermo Endura. He is soon to marry his 24 year old mistress, and is on a special diet so as to lose some 150# for the wedding. However, all the Latin love stories aside, the fact remains that Endura is a Director of a Panamanian bank used exclusively by Columbia's Medellin drug cartel. Do not be so naive as to think that anything has changed with the sacrifice of 26 of our finest men in operation "Just Cause."

The George Bush hand-picked Vice President of Panama is Guillermo Ford, who is also the Chairman of the Banking Commission of Panama. As it happens, he is also part owner of the Dadeland Bank of Florida which was named in a court case two years ago as the central institution for the drug cartels.

The George Bush hand-picked new Attorney General of Panama is Rogello Cruz, and according to the NEW YORK TIMES is one of the bosses of the Cali drug cartel of Columbia. All this fits with what I wrote years ago in HOPE'S HUSBAND and other pamphlets, regarding George Bush and his Drug Connections. I make no apologies. What I saw in Central America and what I know and published from other sources has proven to be true and accurate. The U.S. Government under Bush command is making no effort whatever to rid the Panamanian Government of officials tied directly to drugs. Don't you see? If he did so, they would quickly give their stories to the world news media and bring down a scandal that would make Watergate and the Iran Contra Scandal seem insignificant by comparison. History may record that George Bush was the most dangerous man to ever serve as

Brother Patterson states on page 6 that "Drug Possession is now a CIVIL CRIME." He is quite correctly quoting an announcement by the Bush Administration Attorney General Thornburg's announcement of 12/2/89. In that announcement, Thornburg stated that possession of **no more than** an ounce of marijuana or **no more than** a gram of heroin or cocaine would be prosecuted as a "civil violation" -- not a criminal violation.

Remember I wrote in ENCORE!, the last 24 pages of HOPE'S HUSBAND!, that the government of the United States was formally inserted into a world government on January 19, 1989 without the knowledge of the American people! Since that is true, technically there are no longer any common law Rights guaranteed under the Constitution of the United States, such as those 4th and 5th Amendment protections.

I maintain that the World Government set up in secret during January, 1989 is *ultra vires*, that is, outside the Law and without legal standing. Therefore, I claim my common

law Rights as a Citizen and am not a Subject who must submit to search of my home, person, papers and effects without a properly drawn 4th Amendment Warrant signed by a Judge in my County setting forth under oath the probable cause for believing there is a criminal activity on my part.

Here is the point. Read it carefully! Under American Constitutional Law, and the Laws of every one of the States, there is no such thing as a "civil crime." All crimes, even a humble traffic ticket, are legally criminal in nature and jurisdiction. The only jurisdiction wherein there can be a "civil crime", or where any Court can impose such a penalty, is under Admiralty/Maritime International Law. By what authority does an American, walking around with an ounce of Marijuana, come under the International Law of the Sea? Isn't he supposed to be under "the law of the Land?"

What is the only way that a citizen of the United States of America can be reduced to a "Person subject to Admiralty/Maritime Law" without Constitutional Rights? Only by Contract. By what contract has an American been forced into such jurisdiction? There may be a number of them which he is absolutely unaware of until it is too late to unravel his personal affairs and then **timely claim** his lawful rights. With all due respect to my friend Larry Patterson, no federal law can be passed that will do away with the 4th Amendment. For an American to be subject to search and seizure without a 4th Amendment warrant, he must have already waived those Rights by contract or he must have failed to object timely prior to the search.

I am not going to take time and space to list those typical contracts wherein many have waived, albeit inadvertently and perhaps through fraud, their common law rights. That has been published previously. However, with all due disrespect to Attorney General Thornburg, I am not a person subject to such searches without a warrant. I am not under the jurisdiction of any court who can impose such prosecution for "civil violations." Are you

now beginning to see why I must write on so many seemingly different subjects and then show how they blend together?

Here is another thought that will be a shock to you but do not misunderstand me or draw conclusions beyond what I am teaching. It is not a violation of American Common Law or any of the common laws of any State, to possess marijuana or cocaine for your own personal use. Until there is a victim, there is no crime. Until you have deprived some other person of life, liberty or property, no crime has been committed, all the statutes and regulations to the contrary notwithstanding. Most Americans these days, (because of the Social Security contract and other contracts that confer upon them maritime jurisdiction), are legally wards of the State. If you are a ward of the State, instead of a Freeman at law, then the State has the jurisdiction to compel you to perform according to contract and take good care of yourself and not smoke "pot". The State has the duty to take care of the property and chattel that it owns, including subjects and persons under contract for their care. Do you see that?

It has long been my position that the totalitarian socialists, which includes George Bush when the final truth is known, want the use of drugs going on as a means of softening up the next generation in prepara-

tion for the New World Order that they are now setting in place. If this were not so, they would stop the drug producing chemicals going to Latin America from American firms, and intercept the millions of dollars going through American banks to Panama, Israel, and other cooperating off-shore banking nations.

Here is how this works. There are no bank reporting requirements if money is wired off-shore. If you carry huge amounts of money through customs and fail to report it, and get caught, it is a crime punishable by a prison term. However, the built-in loophole

He thought that he could control what went on in Panama, and when push came to shove, it is believed that Noriega was about to "nationalize" some or all of the Aoki-Bush Family's \$350,000,000 worth of investments in retaliation for the U.S. indictment of him in Florida. 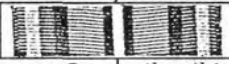

There is a new military medal now being released for those of the Armed Forces who participated in numerous undeclared wars including the recent invasion of Panama known as **Operation Just Cause**. It is called the Armed Forces Expeditionary Medal and I have shown it here. It includes the operations against Libya, Grenada, Cambodia, Laos and the blockade of Cuba in 1962-1963. It includes such missions defined as "peace-keeping" as in the Congo in 1960-62 and Lebanon in 1963-1967. It includes all sorts of unusual operations from 1958 until 1989, some of which are long forgotten as the Naval Blockade off Red China from 1958-1963. I found the release of this new Expeditionary Medal, and the Ribbon that goes with it, a forboding of things to come where American Forces will be used to secure the global schemes of the international socialists and their New World Order.

I reported last month that my contact in
 Panama knew of the **exact time** of the inva-
 sion for almost two days, and now we are
 reading in the NEW YORK TIMES that the Is-
 raeli community in Panama was *given at least*

Americans landed. Of the 26 men who died in
Panama under combat conditions, it is known
that at least 11 of these were U.S. Special
Forces, a highly trained elite among our
Armed Forces. For this many to have been



killed, they had to have
 been betrayed by our
 State Department who,
 in warning their Israeli
 friends, made it possible
 for the Israelis to warn
 the Panama Elite Forces.
 They were waiting for the
 Special Forces to arrive,
 even knowing specifically
 the targetted planes and
 boats secretly hidden for
 Noriega's escape. Harari
 was to Noriega what

 reality of the Panama
 scene, known by the

whole world except America, is that Harari
 was the man that *Noriega reported to, and it*
was Harari who was filling his pockets with
the drug money. In the coming months, un-
less the Panama invasion has been ordered
out of the press speculation by the powers
that be, there will be conflicting stories as to
how the leak came about that alerted Israel
and almost certainly the Noriega forces to the
forthcoming invasion. No matter what hap-
pens, I want you to remember that these 11
Special Forces men died because they were

betrayed by an Israeli Mossad Hit Squad Chief named Michael Harari whose picture I have shown here. No apologies for the rather poor quality of reproduction. These photographs are often hard to get of such high-level covert operatives.

Michael Harari has a very interesting background of murder and sabotage. He holds the Rank of Colonel in the Israeli Mossad, and took over as the Central American Mossad Director in 1980. I saw him only once to my recollection, and it was in central San Jose, Costa Rica on the square in front of the Opera House. He was with two younger agents, and I did get a photograph of them. They were driving a late model brown four door Jeep Wagoneer. One or both of his men were seen by my people observing me on many occasions. Officially, Col. Harari was assigned to the Israeli Embassy in Mexico City, but in fact spent most of his time in Panama where he had a line of associates and contacts since as early as 1973. It was during that period that Noriega was strong man Omar Torrijos's Intelligence Chief, and double-dipping by getting a \$200,000 per year salary as an informant for the CIA then under control of George Bush. He also worked for the MOSSAD as an informant. Isn't it a small world?

Noriega knew Col. Harari from his training in military intelligence in Israel. It is known that Noriega made five jumps with the Israeli Paratroopers and qualified for his Israeli Paratrooper wings, which he wore on his uniform for years. While Noriega was "bought and paid for by Bush's CIA" the fact remains that he was an Israeli creation as to his personal philosophy and military mind-set. Noriega was in his mind, a Zionist. He secretly wished that he was a Jew by birth instead of a Panamanian of uncertain origins. He bought a home in the Herzliya section of Tel Aviv. In Panama, he sent his children to the Jewish Alberto Einstein Day School instead of the Jesuit schools of his early days. He even sent his children to an Israeli Kibbutz one summer. The Panamanian Jewish community numbers around 5,000, but the Israelis con-

trol most of the Central Avenue business district. According to the WASHINGTON JEWISH WEEK of December 28, 1989, the Israelis in Panama:

"...do not reflect well on Israel or the Panama Jewish community....They are engaged in contraband and money laundering. In general they engage in very aggressive and unfair business practices."

It was the Israeli business men, not the Panamanian Jews, who were looted during the confusion following the invasion with reported losses of around a billion dollars. Your government is now going to be taxing you to repay these Israeli businessmen for their losses.

The Associated Press of December 27th quoted a US Embassy official who stated that they had captured Col. Harari. Orders came down from Washington that Harari was to be released, and the next we heard concerning him was on an Israeli TV interview, from Israel, denying that he had anything to do with Noriega's affairs.



Our DEA intelligence sources reveal that Noriega had a mistress named Magdalena Kusmisk. She bore him an illegitimate son in Washington, DC in 1982. Mrs. Noriega, it seems, cast a "voodoo spell" on her, and Noriega had to bring in a Brazilian witch doctor to counter it. Noriega is not a true Catholic believer although he had been raised as one. The Vatican Embassy chose to take him in during "his hour of need". He was not Jewish by religion, only Zionist by international socialist politics. His actual religion is the *Santeria Folk Theology imported into Brazil* by the African slaves. Santeria is similar to Voodoo in that believers worship their gods with personal offerings and think that their magic can control and manipulate their enemies. Unfortunately, Santeria religious practices are commonly mixed in with the Catholic religion in Central and South America, and Noriega attended Catholic services but practiced Santeria in private. Santeria is what makes many Catholics so unpredictable

Latin American countries. The Santeria es ritual homicide and it is known that Noriega had a room in one of his luxury villas at was used for this purpose. There was an altar there to a Brazilian priestess, along with the other usual trappings of the Santeria, such as bottles, beads, candles and dried food offerings. Noriega, with the help of his Santeria gods, tried to influence people by putting handwritten lists of their names under a glob of wax or wrapped around a white candle. Our source is Chief Warrant Officer James Dibble, U.S. Army Specialist in the Occult, stationed at Fort Campbell, KY. Dibble was the man called to inspect the contents of the "ritual rooms" in the Noriega complex.



As you think of these things, remember that the ultimate goal of these international totalitarian socialists is to bring America down so that, as Kissinger wrote in FOREIGN AFFAIRS, "America can be comfortably merged with the Soviet Union." Toward that end, they are quite willing to be promoting the international drug trade for personal financial profit, and at the same time declaring a "war on drugs" for personal political profit. Some of my wonderful readers simply cannot imagine President Bush getting away with this duplicity for all these years. Therefore, they assume that all this cannot be true and that Ford Davis must have exaggerated the facts. Well, George Bush has not gotten away with it, for a number of us are adamantly exposing him with names, dates and places. We had to laugh, last month, when Bush set up his "drug summit", key to his "war on drugs", in Cartagena, Columbia of all places. Those of us who remember our history, know that Cartagena was the site of the greatest naval invasion defeat of America's pre-revolutionary Latin American escapades. In command of this invasion of Cartagena was an Admiral Vernon and under him in command was one Lawrence Washington, the brother of George, our first President. I do not recall the actual reason for the attack on Cartagena, but when the Yankees went ashore, the ladders they

carried were six feet too short to scale the walls of the Fort, and the Spanish defenders mowed them down by the thousands. Those who survived, with their immune systems not accustomed to the diseases of the tropics, came down with various diseases, and hundreds of them died. Lawrence Washington picked up one of these diseases, which finally took his life. However, Lawrence still named his home after this inept Admiral, calling it Mount Vernon. When Lawrence died, brother George inherited his lands, and today we think of Mount Vernon as being George Washington's home. Had it not been for the fiasco of Cartagena, George would have never lived there.

We can understand the folly of Admiral Vernon and his too short ladders. We can even understand the loyalty of Lawrence Washington to his friend in his final years of disgrace having lost thousands of men on the shores of South America. But the folly of the so-called war on drugs is quite another thing. The plan is to deliberately lose the war, as was done in Vietnam, to exploit inevitable political change in America. The no-win war on drugs serves the secret interests of the International Socialists by subverting the intent of the Bill of Rights that most Americans suppose still protects them from the tyranny of government. Under the pretext of rescuing people from the incalculable perils of rampaging mobs seeking their final fix, or the looting of their homes and ravaging their women by dope heads, the war on drugs is intended to claim for itself enormously enhanced powers of repression and control.

Here is the clue. Right after President Bush's speech in September, declaring the "war on drugs", an opinion poll is reported to show that 62% of all Americans were willing "to give up some freedoms" in order to rid America of the scourge of drugs. As the politically sophisticated know, "opinion polls" are used to create opinions, not monitor them. They are used to determine the effectiveness of the media propaganda. However in this case, it may be quite true that 62% of all Americans would be willing to give up some of

their freedoms to stop drugs, and the totalitarian socialists are certainly hoping you will ask that this be done. Isn't that the way that every dictatorship got started? Hitler controlled the German "Brown Shirts." The Brown Shirts were causing all sorts of civil upheavals. Hitler promised to stop the Brown Shirts and was quickly put in power.

George Bush is directly involved with the drug traffic, not only from Central and South America, but from the Golden Triangle of Northern Burma as well. The drugs are causing all sorts of civil upheavals. Bush promises to declare war on drugs. The people willingly give up freedom and liberty for what they believe will be peace and safety. Well, that is the plan. To prepare for that, we are hearing more and more about the need for more police, more judges, more jails, more prisons, more and longer punishments, and more people serving "serious time."

Along with the totalitarian socialist's zeal for coercion, the politicians of both parties are demanding longer prison terms, and harsher laws. Federal officers confiscate motor vehicles, boats and houses of suspected drug dealers even before these people have had their day in court. They are demanding, and it appears that they will get it, the right to invade almost anyone's privacy: search without a warrant anyone's car or boat; bend the rules of evidence, hire police spies, and monitor phone lines without a warrant. The Supreme Court has ruled that the police can stop, detain and question any person traveling through an airport whom the police say that they "see a resemblance to a drug dealer"---the very lowest level of our 4th Amendment Probable Cause Rights. In a recent ABC Poll it was reported that 55% of all Americans support mandatory drug testing for all Americans.

The enforcement of these "tougher laws" requires additional tiers of expensive government. Of the \$7,900,000,000 dollars

(\$7.9 Billion) that Bush allotted to the war on drugs in September, the bulk of the money goes to swell the budgets of 58 federal agencies and 74 congressional committees already engaged in the "war on drugs." Each of these has its own agenda and armies to feed on the various fronts of the so-called campaign. The government agents have a talent for theft and fraud that is barely distinguishable from the talent for theft and fraud of the drug syndicates they insist that they are fighting.

Some of the statements on the CIA direct involvement with the importation of drugs from Central America are now coming out in the normal press. I know that there are a number of my friends who privately questioned my statements in HOPE'S HUSBAND, supposing, with love, that I must have spent too much time under the hot tropical sun. As I write, there is a Federal trial going on in Tulsa, Oklahoma. The defendant is Jose Abello-Silva who is charged with "conspiracy to import cocaine." A federal witness, a self-confessed drug smuggler named Fabio Ernesto Carrasco, testified that he worked for the defendant, thus proving the government's case of a conspiracy. However

under cross-examination, Carrasco testified that he supervised two CIA-sponsored shipments of weapons to Costa Rica allegedly for the Nicaraguan Contras, and returned to the United States with cocaine for the Central Intelligence Agency! Two years ago, I even told you **where** these planes landed---John Hull's ranch in Northern Costa Rica, and **who** supervised these shipments both ways---Oliver North and his associates. I told you **where** the planes landed in the U.S. with the cocaine---Homestead Air force Base, Florida. I even know the official Pennsylvania owners of the aircraft used, and the amount of cocaine in the shipments: 1,000 Kilograms or just over one ton. The man who could testify that the drugs were picked up by Jeb Bush, the son of the then Vice-President, "committed suicide" in California a couple years ago, allegedly from a cocaine overdose. Nonsense! He was trained Special Forces.

The U.S. has not responded, and this year the region's crop could double from the levels of just a few years ago. Sen. Gen. In the remote hills of Burma, a private army of thousands protect him."

What the U.S. News & World Report states is that Gen. Khun Sa will stop his shipments amounting to 40% of the heroin supply if the U.S. will send his nation financial aid, and from other sources we know that he wants another agriculture crop that he can grow that the U.S. will buy from him so that his economy will function without drug money. What the story does **not** say is that the 1,200 metric tons of refined heroin per year, worth on the street an amount equal to 10% of America's Gross National Product, is being shipped from Thailand on U.S. Air Force cargo planes! One of my NORTHPOINT TEAM members recently finished his military tour of duty and told me that he was ordered to help load some of these shipments. What the story did **not** say is that the U.S. Army Corps of Engineers built a two lane road back into the North Burma mountains so that these shipments could be brought out on trucks instead of the backs of mules. Cocaine seized on Air Force plane

2 arrested after flight from Panama arrives at base in Delaware

DOVER, Del. — Authorities seized 66 pounds of cocaine that was flown aboard an Air Force cargo plane from Panama to Dover Air Force Base and arrested a 13-year Army veteran and his brother, who were to pick up the drugs, federal officials said Saturday.

The shipment, valued at \$3 million, had been monitored from the time it was placed aboard the C-5 cargo plane at Howard Air Base in Panama, said Larry Whitfield, a Drug Enforcement Administration agent in Wilmington, Del.

DEA and Air Force investigators

had learned of the shipment several months ago, he said.

Two men suspected of serving as couriers were arrested by undercover DEA agents and Air Force officials Saturday at a motel where they apparently were waiting for the shipment, Whitfield said.

Arrested were Nathan Thomas, 23, of New York and his brother, Victor M. Thomas, 32, an Army maintenance worker stationed at Fort Riley, Kan., and on leave from his job, Dover Air Force Base spokesman Walter Thorp said.

Both were held on suspicion of conspiracy and possession of cocaine with intent to deliver, Whitfield said.

They were being held at the Delaware Correctional Center near Smyrna pending arraignment Monday in US Magistrate Court in Wilmington.

Officials would not say who placed the drugs aboard the plane or what kind of tip authorities received because they did not want to jeopardize their investigation in Panama, Thorp said.

They also would not say whether any members of the Air Force were suspected of being involved in the smuggling operation. Whitfield said he was not aware of any arrests being made in Panama.

The cocaine — in 30 1-kilogram bricks — had a street value of about \$3 million, Whitfield said. In addition, authorities seized \$73,000 carried by the Thomas brothers, he said.

The C-5 crew was told it was carrying a top-secret cargo but not informed of the contents of the cardboard box holding the cocaine, Thorp said.

Remote island drug prisons part of plan in defense bill

WASHINGTON — Summoning visions of a modern-day Devil's Island, Congress is considering a plan to imprison drug-law offenders on "isolated and shark-surrounded islands" in the Pacific Ocean.

Supporters of the plan say it would help ease prison overcrowding and, as a bonus, help reduce the defense budget by using inmate labor for maintenance work on remote U.S. military outposts.

But critics say the proposal harkens back to a more brutal era of punishment in which inmates were carried off to places like Devil's Island, the infamous French penal colony off the coast of South America that was closed in 1938.

"This is the craziest thing I've ever heard," said Loren Siegel of the American Civil Liberties Union. "Deporting people to do slave labor on an island far out in the ocean is cruel and unusual punishment."

Under the plan, U.S. outposts on the World War II battlegrounds of Midway and Wake Island, tiny coral atolls, would be converted into penal colonies for Americans who are convicted of drug-related felonies.

The proposal is tucked away in an obscure section of the \$283 billion defense authorization bill that is now being debated by the House of Representatives.

A four-paragraph section of the voluminous bill, approved by the House Armed Services Committee on July 31, asks the Pentagon to study the

feasibility of island drug prisons and report back to Congress by next March.

"As an alternative to the shortage of available space for convicted drug offenders and as an effort to reduce the defense budget, utilizing some of these facilities for drug offenders should be considered," the bill says.

The feasibility study is not scheduled for debate and is expected to be approved as part of the full defense bill sometime this week.

Midway is a two-square-mile coral atoll about 1,500 miles northwest of Hawaii; Wake Island is a three-square-mile atoll about 2,300 miles west of Hawaii.

The two islands were focal points of Pacific operations during World War II, and Midway was the site of one of the U.S. Navy's most decisive victories.

Today, the atolls are maintained by the Defense Department as emergency airfields and communications stations.

Neither has any native inhabitants, but several hundred contract workers live on the islands year-round to maintain the U.S. facilities at a cost of about \$8 million a year.

The proposal is the brainchild of Rep. Richard Ray, D-Ga., who called it a "keen idea" for cutting defense costs while at the same time saving money on prison construction costs.

"Using drug offenders to man these isolated and shark-surrounded islands would alleviate some of the overcrowding of federal prisons and save the Department of Defense some money," Ray said.

Report links CIA, Pan Am bombing

**CBS, lawmaker
allege drug deal
resulted in disaster**

NEW YORK — A CIA deal with a heroin smuggler might have played a crucial part in events leading to the bombing in December 1988 of Pan Am Flight 103 over Lockerbie, Scotland, which killed 270 people, CBS reported Saturday.

The bomb was smuggled onto

the aircraft in a suitcase that was supposed to contain heroin, Rep. James Traficant, D-Ohio, said on CBS' "Saturday Night with Connie Chung."

He said he got his information from a confidential report by investigators hired by Pan Am's insurance underwriter.

CBS said Traficant plans to meet with Pan Am officials Monday to question them about the report. It said the CIA has dismissed the allegations as "nonsense."

CBS correspondent Chung and Traficant gave this description of the alleged deal: The CIA had al-

lowed a man with terrorist connections to transport drugs to the United States in exchange for information about US hostages held in Lebanon.

Turkish baggage handlers at Frankfurt airport had been primed to substitute a suitcase containing drugs for a normal suitcase aboard the Pan Am flight. But Ahmed Jibril, allegedly hired by Iranian officials to place a bomb on a US carrier, knew of the drug run.

"Jibril knew of the drug run ... and he was able to orchestrate a situation where, instead of the drugs, he put the bomb on 103,"

Traficant said on CBS. "And he was able to get a bomb on it because that thing was insulated by the CIA for a drug run."

According to CBS, West German intelligence, aware of the drug-running scheme, had placed the baggage for the Pan Am flight under video surveillance and reported to the CIA that the smuggler was not using his usual suitcase but had placed a brown Samsonite bag on the plane.

Traficant said the investigators found out that German intelligence notified the CIA. "They notified Washington and were told 'Disregard,'" he said.

Ex-CIA agent says diary referring to Kennedy assassination is hoax

HOUSTON — A diary claiming a Dallas policeman shot President John Kennedy was unveiled Thursday, but a leading assassination theorist immediately labeled it a hoax.

The diary included notations in which the late Dallas police officer Roscoe White supposedly confessed to participating in a Central Intelligence Agency plot to kill Kennedy, who was shot to death in Dallas on Nov. 22, 1963.

"They want me to kill the president. God help me. They say he's a threat to the United States," a line in the document said.

Private investigator Joe West showed copied pages from the diary at a news conference.

West said White's widow, Geneva White Galle, found the diary recently in the garage of her Midland, Texas, home.

She allowed him to make copies because she was dying and "wants to use the few days she has left to let the truth be known," he said.

But former CIA agent John Stockwell, who has written extensively on the possibility that Kennedy was killed by a government-led conspiracy, said at the same news conference that the diary appeared to be a fraud.

"I believe when analysis is done, it will show this document is a fabrication — and one that's fairly easy to expose," said Stockwell, who was allowed to view the actual document this week. He declined to speculate on who might have

pertrated the alleged fraud.

He said the document refers to the Watergate break-in committed by the Nixon re-election campaign almost a year before it happened. It also appeared to have been written with a type of felt-tip pen that was not available during part of the time — from 1956 to 1971 — White supposedly wrote.

White died in a fire in 1971.

West, who has investigated the Kennedy assassination for two years, said he could not guarantee the veracity of the diary.

The document also talks about White's involvement with alleged Kennedy assassin Lee Harvey Oswald, Oswald murderer Jack Ruby and a Mafia gunman who supposedly also took part in the assassination.

APPENDIX G: KURZWEIL VS. HOPKINS

SWORN AFFIDAVIT OF DR. STEVE KURZWEIL

I originally became interested in the UFO subject by meeting Harry Lebelson, a writer for OMNI Magazine who told me about cattle mutilations and urged I attend an APRK meeting. I was not very impressed with the meeting, but rather with an attractive woman named Joan Thompson who appeared to be one of the few non-strange looking people at the meeting. Ms. Thompson and I became friends and later together we attended a MUFON meeting held in Boston. (This was about 1981.) Ms. Thompson explained that she was an employee of the CIA and asked that I work with Mr. Budd Hopkins to help with his research. (1982) Mr. Hopkins explained that he likewise was an employee of the CIA: "I'm the CIA's top specialist for them." He was extremely concerned that the covering books he'd written lest "there be a revolution in this country". He fearfully told me that " alot" of people have been abducted; "we don't know what the UFOs did to them; I wrote the book to find out who had been abducted ("Missing Time"); "the Gov't. has to get these people out of the military; they (i.e., the CIA) think China sees may have been programmed." He was very upset about the amount of work required to investigate even one case. Mr. Hopkins said, "distrust the information passed on while obtained under hypnosis". He was shocked by the after effects of abductions; people frequently committed suicide FOLLOWING his "hypnototherapy"; many went on to become alcoholics or drug addicts such as Ms. Nancy Drexler. I asked him why he did the hypnosis if it caused the psychological and psych.atric problems! He could offer no reply whatsoever despite my repeated questioning. I myself was appalled by the inhumane and medically indecent standards of "care" being applied to these victims of Nazi-like brutality. By all medical standards Mr. Hopkins was further causing injury to individuals already in distress. He made no provision for aftercare or follow-up. He displayed a complete lack of temperament and training (as well as a complete lack of compassion) for for these people. Once he obtained his "information", he would drop these people like hot potatoes and left them on their own. As a medical doctor I was disgusted; as an American I was sickened at this maltreatment of our own people. I refused to cooperate with Hopkins and reported him to the Medical Authorities as being involved in harmful and extremely questionable activities that were anti-humanitarian as well as anti-American. He threatened to get revenge by reporting me as "mentally impaired" since I believed in a government cover-up and reported harassment. This, he claimed, was evidence of paranoid delusion. "Steve, you had the nerve to tell me to F--- Myself" and "that's why I'm getting back at you". The New York State Office of Professional Conduct was told lies (1989) about my involvement in this subject. The State is required by law to investigate all reports (even by non-patients) of possible physician impairment. When the psychiatrist interviewed me I told him about the fact that the public knows nothing of this deplorable situation. He concluded that I was paranoid delusional (due to the telephone harassment) and that I was "grandiose" since I had "special knowledge". The psychiatrist is an 85 year old man who believes he knows all there is to know from his textbooks on psychiatry. My medical license is now on the line and hence my entire future career!! I would like to add that since I have been practising medicine since 1968 there has NEVER been even one case of any patient of mine who questioned my professional expertise, personal integrity or ethical standards. Since I originally reported Hopkins in 1983, I have received numerous telephone calls at all hours; notices from funeral parlors, interruption of my medical practise by "a third party" answering my line giving misinformation out to patients resulting in complete chaos to my office and grief to myself. This was told to me by Ms. Avonile Blackman, my telephone secretary (1984). An "extra-cross connection" or illegal tap was reported on my phone by Charles Lauretano of the NY Telephone Company. My life has been a nightmare ever since standing up

and speaking out for my rights as a patriotic American citizen!

Please accept this letter as our comments on behalf of Dr. Kurzweil for your consideration in issuing the Commissioner's recommendation to the Board of Regents in this matter.

It is uncontested that there is no evidence of any patient harm in this case. In all of the documentary evidence presented by BPMC never is any reference made therein by Dr. Kurzweil to patients or his medical practice. There is therefore no tangible evidence of or basis upon which any reasonable inference can be drawn of any potential for patient harm.

We urge you in reviewing the transcript to carefully consider the credible testimony of two expert witnesses, Dr. Schwartz, a psychiatrist and Dr. O'Rourke, a psychologist, who have extensive experience and training not just generally in psychiatry/psychology, but more specifically and relevantly to this case, in assessing the mental health of individuals directly and specifically as to its relationship to the individual's occupational fitness.

Dr. Schwartz carefully reviewed the entirety of the documentary evidence presented by BPMC, had two formal and several informal interviews with Dr. Kurzweil to assess his mental status generally and to question him about the extensive correspondence with Mr. Hopkins and telephone messages, and he ordered psychological testing as another mode of confirmation. Dr. O'Rourke administered the psychological tests and interpreted the tests and compared the results of the tests to the results of tests administered by another certified psychologist in 1981. There was no evidence of any major mental disorder; no substantiation of the

diagnosis and assessment made by LPMC's psychiatrist, Dr. Bryt, on the basis solely of one interview and nothing more; nor was there any information elicited that demonstrated patient harm on any potential whatsoever for patient harm.

Dr. Kurzweil's relationship with Mr. Hopkins is certainly unfortunate, irregardless of the conflicting psychiatric labels attached to it, because it is that relationship, and nothing whatsoever involving his medical practice, that was the predicate for the instant proceedings. Mr. Hopkins in fact testified that he actively solicited various medical specialists to participate in his self-styled research by examining "abductees" but that Dr. Kurzweil had never become so involved. It is Dr. Kurzweil's concerns over Mr. Hopkins, a person with no medical or research or any formal training other than as an artist, engaging in potentially harmful hypnosis, experiments on individuals labeled as abductees by Mr. Hopkins, that led him to report these experiments, recently acknowledged by Mr. Hopkins in a "mystery" show on prime time television, to the authorities. Dr. Kurzweil's good faith inquiries as a physician to the Health Department and New York State Medical Society about these uncontrolled experiments by Mr. Hopkins are what led to an investigation of his relationship Mr. Hopkins and the instant proceedings.

As the record indicates, Dr. Kurzweil is certainly not a wealthy man and his medical license is his only means of earning a livelihood to support himself and his infirm mother. He does not have a family and the ability to practice medicine is truly his whole life. The fact that his license has been placed in jeopardy by these proceedings has effectively served as a deterrent to his continuing his relationship with Mr. Hopkins and generating the emotional intensity of concern, in terms of its potential, to the Hearing Committee. Dr. Kurzweil most importantly has demonstrated that he has the capacity to modify his behavior appropriately in that he has not contacted Mr. Hopkins since early May.

The documentary evidence, relied upon exclusively by the Hearing Committee in its report as the factual underpinnings, for its conclusion and penalty recommendation was correspondence directed to Mr. Hopkins or generated by his relationship with Mr. Hopkins and Mr. Hopkins' work with "abductees". Thus, it is clear that the conduct which resulted in the Hearing Committee's

recommendation was unique to Dr. Kurzweil's involvement with Mr. Hopkins and that relationship has been concluded. The termination of Dr. Kurzweil's interest in Mr. Hopkins and his activities has thus eliminated the 'potential' of concern by the Hearing Committee. As importantly, by this long and troubled chapter in his life finally coming to a conclusion, Dr. Kurzweil has been able to again focus his energies entirely on his career and find ways to channel his energy productively and appropriately by building up his practice and/or finding appropriate employment in medicine.

It is respectfully requested that strong consideration be given to the assessment of Doctors Schwartz and O'Rourke, the fact that there is no evidence of patient harm nor is there any tangible evidence of or credible psychiatric basis for inferring any potential patient harm and the fact that conduct at issue was unique to Dr. Kurzweil's relationship with Mr. Hopkins and that Dr. Kurzweil has shown the capacity to appropriately modify his conduct by ending the relationship and moving forward with his life. We respectfully suggest that accordingly the Commissioner's Recommendation should be a modification of the Hearing Committee Recommendation as follows: That Dr. Kurzweil be limited to practicing in an institutional or other supervised setting until there has been assessment and treatment, if any, by an approved psychiatrist. This penalty recommendation would be a more appropriate response to the record as a whole while giving the Health Department and the Board of Regents assurance that any concerns about public health, safety, welfare would be adequately safeguarded.
