Summary

OCWA – Central New York's Water Authority is currently seeking candidates for a Water Distribution Maintenance Manager to lead the Distribution Maintenance Department. The work involves responsibility for planning, organizing, and directing department personnel to operate, maintain, install, and repair the water distribution and transmission system. The incumbent has comprehensive oversight for ensuring that the Authority is in compliance with all regulatory requirements and provides professional advice to management on the resources required to maintain the Agency's distribution system in a safe, reliable and cost-effective manner. The incumbent will establish and implement an effective maintenance and repair program to meet the daily needs of OCWA customers and meet the goals of the agency.

Minimum Qualifications

Graduation from a regionally accredited college or university, or one accredited by the New York State Board of Regents to grant degrees with an Associate's degree or higher in Design and Engineering, Construction Management, Engineering Technology, Business Management or a closely related field and eight (8) years of progressively responsible management experience, four (4) years of which must have been in a supervisory capacity in a public works, engineering or construction department.

SPECIAL NECESSARY REQUIREMENT: Possession of a valid New York State driver's license at time of appointment. Completion of a Grade D water license within 18 months of appointment.
