## THE LYCRA COMPANY HANGTAG APPLICATION GUIDELINE

### **Online Hangtag Ordering Steps**

1. Check with your fabric suppliers that the fabrics you order are meeting The LYCRA Company's quality standards.
2. Complete the online request hangtag form at [www.hangtags.LYCRA.com](http://www.hangtags.LYCRA.com).
3. You will receive a confirmation email from The LYCRA Company with an address to send your fabric for testing.
4. Normal lead time is 2-3 weeks including fabric testing and hangtag delivery. If your fabric has been tested and approved in the past and does not require The LYCRA Company laboratory test, the lead time is shortened to 1 week for hangtag delivery.
5. Hangtags are delivered to garment manufacturers, brand houses, buying offices or sourcing agent. We do not deliver hangtags to fabric suppliers.

### **Garment Requirements**

#### **All Garments (Except Intimate Apparel/Underwear, Swimwear and Legwear )**

- To qualify for LYCRA® fiber, COOLMAX® fabric, THERMOLITE® fabric, TACTEL® fiber and SUPPLEX® fabric hangtags, 80% of the garment must be made with the approved fabrics on the outside.
- To qualify for "Lined with COOLMAX® fabric" hangtags, 80% of the garment's lining must be made with the approved COOLMAX® fabric.

#### **Intimate Apparel/Underwear**

- Intimate apparel/underwear: to qualify for LYCRA® fiber, COOLMAX® fabric, THERMOLITE® fabric, TACTEL® fiber and SUPPLEX® fabric hangtags, 50% of the garment must be made with the approved fabric on the outside.
- To qualify for LYCRA® fiber hangtags, the narrows, waistband, or other elastified fabrics in the same garment must be made with LYCRA® fiber. If the waistband is made with "rubber", the request may be reviewed by The LYCRA Company for approval.
- To qualify for hangtags with LYCRA® beauty fabric brand for intimate apparel, the garment must be considered to be shapewear.

## Swimwear

- To qualify for the Xtra Life LYCRA® fiber hangtag, 80% of the garment must be made with fabric qualifying for the Xtra Life LYCRA® fiber brand, using the approved fabric on the outside.
- To qualify for the LYCRA® beauty fabric for Swimwear hangtag, 25% of the garment must be made with LYCRA® beauty fabric for Swimwear (inner or outer layer). In addition, 80% of the garment must be made with fabric qualifying for the Xtra Life LYCRA® fiber brand, using the approved fabric on the outside.

## Legwear

To qualify for stickers, socks and hosiery must pass the branding qualifications standard available from your The LYCRA Company representative.

## Application Requirements

- Know the fabric details of your order. You may find all the fabric details required for completing The LYCRA Company hangtag online request form in your fabric supplier's invoice.
- Application may be delayed if the hangtag request form is received with incomplete information and The LYCRA Company reserves the right to reject the application.
- When hangtag requestors receive The LYCRA Company's confirmation email, they have to send:
  - a) A hard copy or a scanned copy of the fabric or yarn supplier's commercial invoice to the contact provided in the email. We do not accept proforma invoice.
  - b) 1.5 meter full width finished fabric samples or a garment sample to the address provided.  
The LYCRA Company reserves the right to request a garment sample for any hangtag order.  
Garment/Finished Products samples are always required for the following:
    - I. Application of COOLMAX® fabric hangtag and THERMOLITE® fabric hangtag.
    - II. Intimate apparel and small sized garments or accessories.
